CITY RESOLUTION NO. 02-10-2025

A RESOLUTION APPROVING THE COMPOSITION OF THE REGULAR COMMITTEES OF THE TENTH CITY COUNCIL

WHEREAS, Rule VIII, Section 15 of City Resolution No. 01-10-2025 titled “*Resolution Adopting the Internal Rules of Procedure of the Tenth City Council of Tuguegarao City*” states that:

“A regular committee shall be composed of a chairman, vice chairman and three (3) members. The chairman of each committee shall be elected by the members of the Sangguniang Panlungsod except for the Oversight Committee whose chairman shall be the Presiding Officer. The vice chairman and the members of each committee shall be nominated by the chairman thereof whose nomination shall be confirmed by the members of the Sangguniang Panlungsod. Provided, that the sectoral representatives, the President of the Liga ng mga Barangay and the Sangguniang Kabataan President shall ipso facto chair the committees corresponding to their respective sectors”;

WHEREAS, pursuant to the above-cited rule, the Body nominated and elected the different chairmanships of the regular committees during the 1st Regular Session held on July 01, 2025 after the Internal Rules of Procedure was approved;

WHEREAS, the different Chairpersons nominated the Vice Chairpersons and Members of their respective committees for confirmation by the Body.

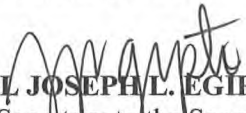

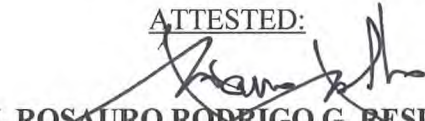
