**FOR THE PRESIDING OFFICER:**

The Members of the Joint Committees met and deliberated on the Indorsement of the City Mayor, Hon. Maila Rosario S. Ting-Que, on the letter of the City Treasurer, Mr. Buenaventura F. Lagundi, relative to the adoption of a resolution authorizing the City Treasurer to process the application for Authority to Print the accountable forms for the Tuguegarao City People's General Hospital and Tuguegarao City Commercial Center at the Bureau of Internal Revenue. The Joint Committees respectfully submit the herein Committee Report and has the honor to report to this August body in session the following actions taken, its findings and recommendations.

**ACTIONS TAKEN:**

1. The joint committees conducted a thorough and wholistic evaluation on the letter of the City Treasurer, Mr. Buenaventura F. Lagundi, relative to the adoption of a resolution authorizing the City Treasurer to process the application for Authority to Print the accountable forms for the Tuguegarao City People's General Hospital and Tuguegarao City Commercial Center at the Bureau of Internal Revenue on January 11, 2024.

2. Resource persons were present to assist the committee in the committee deliberation.

**FINDINGS:**


1. The Tuguegarao City Government own and manage the operation of the Tuguegarao City Peoples General Hospital (TCPGH) located at Luna Street, Centro 6, Tuguegarao City, and the Tuguegarao City Commercial Center (TCCC) located at Centro 7, Tuguegarao City.
2. In the collection of fees, the TCPGH, and the TCCC, are using the accountable forms or official receipts printed by the authorized government printers.
3. The Authority to Print (ATP) the accountable forms shall be applied to and approved by the Bureau of Internal Revenue (BIR).
4. The BIR requires the submission of a Resolution indicating the purpose and name of the authorized representative.
5. Mr. Buenaventura F. Lagundi, City Treasurer, is the custodian of all accountable forms requisitioned by the LGU-Tuguegarao City pursuant to Section 86 of the Local Treasury Operations Manual, 2<sup>nd</sup> Edition.
6. There is a need for the passage of a Resolution authorizing the City Treasurer, Mr. Buenaventura F. Lagundi, to process the application for the Authority to Print the accountable forms for the Tuguegarao City People's General Hospital and Tuguegarao City Commercial Center at the Bureau of Internal Revenue
