**CITY RESOLUTION NO. 09-10-2025**

**A RESOLUTION AMENDING CITY RESOLUTION NO. 02-10-2025 “APPROVING THE COMPOSITION OF THE REGULAR COMMITTEES OF THE TENTH CITY COUNCIL” PARTICULARLY THE COMMITTEE ON EDUCATION**

**WHEREAS**, the Tenth City Council, in its 1<sup>st</sup> Regular Session held on July 01, 2025, adopted and approved City Resolution No. 02-10-2025 “*Approving the Composition of the Regular Committees of the Tenth City Council;*”

**WHEREAS**, Hon. Mariel Ayna T. Calimag tendered her resignation as Vice Chair of the Committee on Education during the 2<sup>nd</sup> Regular Session held on July 08, 2025;

**WHEREAS**, the Internal Rules of Procedure, particularly Section 19 (c) on Committee Procedures, states that:

*C. **Vacancy** – When a vacancy in the chairmanship and vice chairmanship of a committee occurs by reason of resignation due to a valid reason accepted by the Presiding Officer or incapacity, the Presiding Officer shall take over its chairmanship until a regular chair or vice chair is elected by a majority vote of all the members of the Tenth City Council, provided that election shall be made not later than after two (2) regular sessions. When a vacancy occurs in the membership of a committee, the same shall be filled by the chair and concurred by majority vote of all the members of the committee.*

**WHEREAS**, in view of the foregoing, the Presiding Officer opened the nomination for the position of the Vice Chair of the Committee on Education, with Hon. Te nominating Hon. Quilang and Hon. Soriano nominating Hon. Avila;

**WHEREAS**, the division of the house yielded seven (7) votes for Hon. Quilang (Hon. Ramirez, Hon. Quilang, Hon. Te, Hon. Calimag, Hon. Dayag, Hon. Apostol and Hon. Tuddao) and another seven (7) votes for Hon. Avila (Hon. Soriano, Hon. Ortiz, Hon. Bayona, Hon. Baccay, Hon. Avila, Hon. Mangada and Hon. Viernes), with the Presiding Officer breaking the tie by choosing Hon. Quilang;



**WHEREAS**, the Committee on Education shall now be composed of:


