- FINDINGS on the request for an authority to seek and accept in kind and/or financial support from stakeholders and/or partners to defray expenses for the Patronal Fiesta:
 - 1. All monies or any form of assistance shall be properly receipted and inventoried by the Office of the City Treasurer, subject to the usual accounting and auditing procedures, and shall accrue to the Trust Fund for the conduct of the Patronal Fiesta.

- FINDINGS on the recommendation of the City Treasurer, Mr. Buenaventura F. Lagundi, to collect participation fee for the Trade and Food Fair during the 301st Tuguegarao City Annual Patronal Fiesta 2025:

- 3. The participation fee will be collected by the City Treasurer's Office before the conduct of the Trade Fair and Food Fair which shall accrue specifically to the General Fund to augment expenses for the ensuing Patronal Fiestas.
- FINDINGS on the request for an authority to sign for and on behalf of the Tuguegarao City Government the Memoranda of Agreement, contracts and other related documents with the different suppliers in connection with the conduct of the 301st Tuguegaraon City Annual Patronal Fiesta.

After Atty. Renz Angelo Umambong of the City Mayor's Office explained, among others, that the authority is limited only to transactions in connection with Pavvurulun AFI Festival 2025, the committee finds the request to be in order and with merit.

DRAFT RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR, HON. MAILA ROSARIO S. TING-QUE, TO SIGN ALL CONTRACTS AND AGREEMENTS WITH SERVICE PROVIDERS FOR THE EVENTS OF THE PAVVURULUN AFI FESTIVAL

WHEREAS, under Section 16 of Republic Act. No. 7160, otherwise known as the Local Government Code of 1991, provides that "Every Local Government Unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate or incidental for its efficient governance, and those which are essential to the promotion of the general welfare;

WHEREAS, the donations and sponsorships will be of great help to augment the budget of the city for the said celebration of the 301st Tuguegarao City Annual Patronal Fiesta Pavvurulun "AFI" Festival 2025;

WHEREAS, the City Mayor, Hon. Maila Rosario S. Ting-Que, requested from the Tenth City Council for an authority to seek and accept in kind and/or financial support from stakeholders and/or partners to defray expenses for the aforementioned endeavor;

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED,** to authorize the City Mayor, Hon. Maila Rosario S. Ting-Que, to seek and accept in kind and/or financial support from stakeholders and/or partners to defray expenses for the aforementioned endeavor.

RESOLVED FURTHER, that all monies or any form of assistance should be properly receipted and inventoried by the Office of the City Treasurer, subject to the usual accounting and auditing procedures, and shall accrue to the Trust Fund for the conduct of the said Annual Patronal Fiesta Pavvurulun "AFI" Festival 2025.

CITY ORDINANCE DECLARING THE TEMPORARY CLOSURE FROM VEHICULAR TRAFFIC AND TWO-WAY TRAFFIC FLOW OF SOME STREETS FOR THE CONDUCT OF VARIOUS ACTIVITIES IN CONNECTION WITH THE CELEBRATION OF THE 301st PATRONAL FEAST OF TUGUEGARAO CITY

WHEREAS, pursuant to the pertinent provisions of Section 21 of Republic Act 7160, otherwise known as the Local Government Code of 1991, the Local Government Unit of Tuguegarao is authorized to temporarily close some of the local roads falling within its jurisdiction;

WHEREAS, Tuguegarao City will be celebrating its 301st Patronal Feast of Tuguegarao City in honor of its Patron Saint, San Jacinto de Polonia, on August 7 to August 16, 2025;

WHEREAS, the City Mayor, Hon. Maila Rosario S. Ting-Que, has requested for the temporary road closure of some streets and proposed a rerouting plan in view of the conduct of various activities in celebration of this year's 301st Patronal Feast;

WHEREAS, the Traffic and Rerouting Plan aims to establish parking management system and smooth flow of traffic during the activity, provide safety, security and control m easure, and traffic monitoring and assistance;

WHEREAS, the Tenth City Council in its 1st Regular Session held on July 08, 2025, taking in mind public safety and security, found the request to be in order, with merit and beneficial to the constituents of Tuguegarao City, hence recommended for its approval.

NOW, THEREFORE, be it **ORDAINED,** by the Tenth City Council in session assembled to enact the following ordinance:

SECTION 1. TITLE. This Ordinance shall be known as "CITY ORDINANCE DECLARING THE TEMPORARY CLOSURE FROM VEHICULAR TRAFFIC AND TWO-WAY TRAFFIC FLOW OF SOME STREETS FOR THE CONDUCT OF VARIOUS ACTIVITIES IN CONNECTION WITH THE CELEBRATION OF THE 301st PATRONAL FEAST OF TUGUEGARAO CITY."

SECTION 2. SCOPE AND LIMITATION. This Ordinance shall cover the following on specified dates:

1. August 7, 2025 – GRAND PARADE (1:00 PM – 8:00 PM)

- 1. Temporary closure of Bonifacio Street from corner College Avenue to Gonzaga Street.
- 2. Temporary closure of Aguinaldo Street from corner Bonifacio Street to Mabini Street.
- 3. Temporary closure of Mabini Street from corner Luna Street to Aguinaldo Street.

August 7, 2025 (8:00 AM-12:00 MN) & August 8, 2025 (6:00 AM-12:00 MN)- PANCIT FESTIVAL

- 1. Temporary closure of Bonifacio Street from corner Gonzaga Street to Luna Street.
- 2. Two-Way Traffic Flow of Rizal Street from corner College Avenue to Washington Street.

August 9, 2025 (12:00 NN-12:00 MN) –TUGSAYAW (STREET DANCE COMPETITION)

- 1. Temporary closure of Bonifacio Street from corner College Avenue to Aguinaldo Street.
- 2. Temporary closure of Washington Street from corner Blumentritt Street to Del Rosario Street.
- 3. Two-Way Traffic flow of Rizal Street from corner College Avenue to Washington Street.

August 10, 2025 (6:00 AM - 12:00 NN) - DRUM AND GLOCK COMPETITION

- 1. Temporary closure of Bonifacio Street from corner College Avenue to Aguinaldo Street.
 - 2. Two-Way Traffic Flow of Rizal Street from College Avenue to Washington Street.

August 16, 2025 (6:00 AM to 12:00 NN) - Eucharistic Celebration

1. Temporary closure of College Avenue to Aguinaldo Street from corner Taft Street to Mallillin Street (St. Paul University)

SECTION 3. INFORMATION. This Ordinance shall be disseminated through signages and all mass media outlets in Tuguegarao City including the Facebook Page of Tuguegarao City Information Office.

SECTION 4. IMPLEMENTATION. This Ordinance shall be implemented by the Local Chief Executive through the Public Safety and Security Office (PSSO) in coordination with the Office of the City Chief of Police, City General Services Office and City Information Office.

SECTION 5. EFFECTIVITY. This Ordinance shall take effect on August 07, 2025 to August 16, 2025.
