**RESOLUTION AUTHORIZING THE CITY TREASURER, MR. BUENAVENTURA F. LAGUNDI, TO PROCESS THE APPLICATION FOR THE AUTHORITY TO PRINT (ATP) THE ACCOUNTABLE FORMS FOR TUGUEGARAO CITY PEOPLE'S GENERAL HOSPITAL (TCPGH) AND TUGUEGARAO CITY COMMERCIAL CENTER (TCCC) AT THE BUREAU OF INTERNAL REVENUE (BIR)**

**WHEREAS**, the Tuguegarao City Government owns and manages the operation of the Tuguegarao City Peoples General Hospital (TCPGH) located at Luna Street, Centro 6, Tuguegarao City and the Tuguegarao City Commercial Center (TCCC) located at Centro 7, Tuguegarao City;

**WHEREAS**, in the collection of fees, the TCPGH and the TCCC are using the accountable forms or official receipts printed by authorized government printers;

**WHEREAS**, the Authority to Print (ATP) the accountable forms shall be applied to and approved by the Bureau of Internal Revenue (BIR);

**WHEREAS**, the BIR requires the submission of a Resolution indicating the purpose and name of the authorized representative;

**WHEREAS**, Mr. Buenaventura F. Lagundi, City Treasurer, is the custodian of all accountable forms requisitioned by LGU-Tuguegarao City pursuant to Section 86 of the Local Treasury Operations Manual, 2<sup>nd</sup> Edition;

**WHEREAS**, there is a need for the passage of a Resolution authorizing the City Treasurer, Mr. Buenaventura F. Lagundi, to process the application for the Authority to Print the accountable forms for the Tuguegarao City People's General Hospital and Tuguegarao City Commercial Center at the Bureau of Internal Revenue;

**WHEREAS**, Upon the evaluation of the subject referred, the Committee on Rules, Laws and Ethics and the Committee on Appropriations and Ways and Means recommended for the passage of a Resolution


