SUBJECT: INDORSEMENT OF THE CITY MAYOR, HON. MAILA ROSARIO S. TING-QUE OF THE MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF AGRICULTURE AND TUGUEGARAO CITY GOVERNMENT ON THE IMPLEMENTATION OF PHILIPPINE RURAL DEVELOPMENT PROJECT (PRDP)-SCALE UP.

FOR THE PRESIDING OFFICER:

The Committee on Agriculture Committee on Agriculture and Food, Market and Livestock Auction Center and on Rules, Laws and Ethics met and deliberated on the Endorsement of the City Mayor, Hon. Maila Rosario S. Ting-Que, on the Memorandum of Agreement (MOA) with the Department of Agriculture (DA) and the Tuguegarao City Government relative to the implementation and undertaking of Philippine Rural Development Project-Scale Up.

ACTION TAKEN:

The Chairman Hon. Bienvenido C. De Guzman II formally opened the meeting of the Committees on Agriculture and Food, Market and Livestock Auction Center and on Rules, Laws and Ethics to discuss the terms and conditions, obligations and responsibilities of the parties in the subject memorandum of Agreement. Hon. Jude Bayona, Vice-Chairman of the Rules, Laws and Ethics facilitated the discussions.

FINDINGS:

In the proposed Memorandum of Agreement, it is stated that Tuguegarao City Government shall be the Proponent Local Government Unit for the Philippine Rural Development Project (PRDP) to be implemented by the Department of Agriculture (DA).

Upon clarifications from the City Agriculture Office through City Agriculturist Ms. Evangeline Calubaquib, she admitted that they do not have the guidelines regarding the conduct of PRDP Projects to be undertaken by the Local Government Unit.

Hon. Bayona inquired what particular project the City Government will propose under the PRDP. City Planning and Development Office through Ms. Chona Sedano stated that the project will be a Five (5) kilometer Farm to Market Road from Libag to Dadda, Tuguegarao City. She stated that they already started some preparatory activities like peoples' consultation, identification of affected persons, families and areas to be covered by the project. She also stated that they initially prepared the requisite feasibility study, engineering and survey.

Hon. Bayona informed the resource persons from the Office of the Local Chief Executive that there is a need to institute expropriation proceedings for the taking of real properties affected or covered by the project. The proceeding is required whether the lot owners signified their intention or no objection to the use of their private real properties for the project. The lot owners should be required to execute the proper waiver of right, deed of donation or voluntary sale of their real properties.

Hon. Ronaldo Ortiz supported and reiterated the request of Hon. Bayona for the following:

1. Guidelines in undertaking the PRDP Project
2. Submission of the Final and approved Feasibility Study of the Project;
3. Survey Plan of the exact area location;
4. Names and Number of lot owners covered or traversed by the construction of the proposed "Farm to market Road Project to be submitted for the PRDP Project;
5. Waiver of right, or any deed from the lot owners;
6. Building Plan;
7. Cost of the Project;
8. Other important documents in support of the undertaking.

The City Planning and Development Office undertook the responsibility for the Tuguegarao City Government as the Proponent Local Government Unit to comply with the documentary requirements before the Committees will proceed in reviewing the terms and conditions of the Memorandum of Agreement to insure its effective implementation and attain the goals of the project.

After thorough discussions and deliberations, while the Committees find that the project is beneficial to the people of Tuguegarao City for the implementation of Philippine Rural Development Project (PRDP) of the national government, there is the necessity for those responsible offices and persons to submit the above mentioned documents.
