ACTIONS TAKEN:

The Joint Committees, to which the matter was referred, met on January 18, 2024 to tackle the subject matter with the presence of resource persons.

FINDINGS:

1. Under Section 33 of RA 7160 otherwise known as the Local Government Code of 1991, Local Government Units may undertake cooperative undertakings for the common benefit of their constituents;
2. The Provincial Government of Cagayan sees the importance of such joint undertaking for effective local governance in promoting good governance and general welfare;
3. The Province of Cagayan on a yearly basis allocates an amount for their No Barangay, No Town and City Left Behind Program since the time of the Provincial Governor, Hon. Manuel N. Mamba.
4. The Tuguegarao City Government and the different municipalities receives their share from the City/Municipality No Town Left Behind Program Agenda of the Governor.
5. The Provincial Government of Cagayan is extending Financial Assistance to the Tuguegarao City Government amounting to Two Million One Hundred Thousand Pesos (P 2,100,000.00) funded under the CY 2023 Development Assistance to LGUs of the Province.
6. The City Planning and Development Coordinator, Ms. Chona Q. Sedano, EnP, mentioned during the meeting that they have already identified and submitted to the Provincial Government particularly the Provincial Planning and Development Office the priority program/project which is Phase 2 of the concreting of Road at Caggay amounting to Two Million One Hundred Thousand Pesos (P2,100,000.00).
7. There is a need for the passage of a resolution granting authority to the City Mayor, Hon. Maila Rosario S. Ting-Que, to sign for and on behalf of the Tuguegarao City Government the said MOA.


RECOMMENDATIONS:



ROSARIO S. TING-QUE, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO
CITY GOVERNMENT THE SAID MOA.**

MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This Memorandum of Agreement made and entered into this _____ day of _____, 202__ at Tuguegarao City, Philippines by and between:

The **PROVINCIAL GOVERNMENT OF CAGAYAN** with principal office at the Capitol Hills, Tuguegarao City, Cagayan, herein represented by its Provincial Governor, **MANUEL MAMBA**, herein referred to as the **First Party**;

and

TUGUEGARAO CITY represented by its Mayor **MAILA ROSARIO S. TING-QUE** and herein referred to as the **Second Party**;

WITNESSETH:

WHEREAS, under Section 33 of RA 7160 otherwise known as the Local Government Code of 1991, Local Government Units may undertake cooperative undertakings for the common benefit of their constituents;

WHEREAS, the Provincial Government of Cagayan sees the importance of such joint undertaking for effective local governance in promoting good governance and general welfare;

WHEREAS, the Provincial Government of Cagayan is extending financial assistance amounting to _____ funded under the CY 2023 Development Assistance to LGUs of the Province (which shall be herewith referred to as Project Fund) to the Second Party for the _____ which shall herewith referred to as the project;

NOW THEREFORE, for and in consideration of the general welfare of the residents of _____, Cagayan, the two parties voluntarily agree and stipulate the following terms and conditions:

Section 1. **The Project.** This MOA governs the implementation for the _____ the amounting to _____.

Section 2. **Release and use of project funds.** The first party shall release to the second party the fund within ___ days from the signing of this MOA. The second party shall use the project only for the above-mentioned project;

Section 3. **Period of Implementation.** The project has to be implemented within _____ days from the release of the fund to the second party;

Section 4. **Monitoring.** The First Party shall monitor the implementation of the project in conformity with the approved Program of Work and specifications submitted;

Section 5. Report and liquidation. The Second Party shall provide the First Party with the appropriate report of implementation and will liquidate the project funds within thirty (30) days from the completion of the project or prior to the granting of succeeding financial assistance, if any. The Second Party, upon request of the First Party shall make available all papers, documents, reports and records relating to the project for inspection and examination.

Section 6. Amendment. Any modification or amendment of the terms, conditions and covenants under this Memorandum of Agreement, in order to be valid and binding must be mutually agreed upon in writing by the Parties.

Section 7. Effectivity. This Agreement shall take effect on the date of signing hereof by the Parties and shall be terminated upon satisfactory fulfilment of all terms and conditions embodied herein.
