FOR THE PRESIDING OFFICER:

The Members of the Joint Committees met and deliberated on the Letter of Punong Barangay of Centro 10, Hon. Mariano Q. Baylon Jr., on various Barangay Ordinances. The Joint Committees respectfully submit the herein Committee Report and has the honor to report to this August body in session the following actions taken, its findings and recommendations.

ACTIONS TAKEN:

The joint committees conducted a thorough and wholistic evaluation on the Letter of Punong Barangay of Centro 10, Hon. Mariano Q. Baylon Jr., on various Barangay Ordinances.

Resource Persons were present to assist the joint committees in the committee deliberation.

FINDINGS:

- 1) Barangay Centro 10 requested from the Sangguniang Panlungsod the approval of the following Barangay Ordinances, to wit:
 - a) "An Ordinance Mandating Curfew Hour of Billiard Halls at 10:00 O'Clock in the Evening to 5:00 O'Clock in the Morning and Prohibiting Minors to Play and Imposing Penalties Thereof"; and
 - b) "An Ordinance Prohibiting Peer Drinking Alcohol Along Shoulders of the Major Streets of Barangay Centro 10 Imposing Penalties Thereof"
- 2) The joint committees found out that there are already existing City Ordinances relative to the Regulation of the Operation and Maintenance of Billiard Halls in Tuguegarao City and the Prohibition of the use of streets, alleys, road-right of ways, parks and open public spaces for drinking liquor and other intoxicating beverages.

RECOMMENDATIONS:

After a thorough discussion on the subject matter, the committee hereby recommends that Centro 10 shall come up with Resolutions Adopting and Strongly Implementing the following, to wit:

- 1. City Ordinance No. 06-2001 titled "An Ordinance Regulating the Operation and Maintenance of Billiard Halls in the City of Tuguegarao" and City Resolution
- 2. City Resolution No. 218-2002 titled "A Resolution Enacting City Ordinance No. 13-2002 entitled "An Ordinance Prohibiting the Use of Streets, Alleys, Road-Right of Ways, Parks and Open Public Spaces for Drinking Liquor and Other Intoxicating Beverages"
