CITY RESOLUTION NO. 27-09-2025

RESOLUTION REQUESTING THE CITY MAYOR, HON. MAILA ROSARIO S. TING-QUE, TO GRANT FINANCIAL ASSISTANCE TO MR. PHILIP JAMES DALIBA ET AL. FROM CENTRO 05 WHO SUFFER FROM ACUTE BACTERIAL MENINGITIS

WHEREAS, Mr. Philip James Daliba of Centro 05 furnished the Ninth City Council with his letter sent to the City Mayor, Hon. Maila Rosario S. Ting-Que, regarding his complaint on the alleged unsafe and contaminated meat he bought at the auction market in Libag that had posed health risks to his family members;

WHEREAS, the said complaint was included in the Agenda of the 118th Regular Session held on December 11, 2024 under Information and Other Matters where it was ruled by the Presiding Officer to invite the complainant to the next Regular Session;

WHEREAS, the complainant appeared during the 119th Regular Session held on December 17, 2024 at Cataggaman Nuevo and was requested to submit their medical abstracts to the Council next Regular Session;

WHEREAS, during the 121st Regular Session of the Ninth City Council on January 14, 2025, upon perusal of the Medical Certificates indicating Acute Bacterial Meningitis as diagnosis and the manifestation of Kim Gandingan, representative of the complainant, the nature and causes of the said disease were discussed and that it is connected with the brain;

WHEREAS, the complainant manifested during the said Regular Session that they only wanted financial assistance to augment their medical bills and others;

WHEREAS, the granting of financial assistance is not an admission of guilt since no evidence shows that the City is at fault, however, it was the consensus of the Body that there is a need to improve the slaughterhouse services.
