WHEREAS, **MA. AVIANA CHANTAL S. ZAMBALE** is a Grade 4 pupil of Tuguegarao West Central School, a resident of Pallua Norte, Tuguegarao City and the daughter of Police Major Tristan John Zambale and Charlene Mae Zambale;


