**SUBJECT:**

**FINDINGS:**

1. The National Police College (NPC) located at Camp General Mariano N. Castañeda, Silang, Cavite was established pursuant to Section 66 of RA 6975 duly operationalized on February 14, 1994 is mandated to provide continuing education and career training needs to uniformed personnel of the Philippine National Police (PNP), Bureau of Fire Protection (BFP) and Bureau of Jail Management and Penology (BJMP).

2. The National Police College (NPC) is the counterpart of the National Defense College of the Philippines (NDCP), Joint Command and General Staff College (JCSC) and the Training Command 9TRACOM) of the Armed Forces of the Philippines (AFP).
3. One of the Educational Programs/Career Courses of the National Police College is the Public Safety Officers Basic Course (PSOBC) which is a one (1) year resident training program for the intended for lateral entry uniformed commissioned officers with the rank of Inspectors and Senior Inspectors in the police bureau to equip participants with basic knowledge, values, skills, competencies and introductory officers functions and leadership in the public safety, especially in the police service.
4. P/Capt. Kristy Joy Beran Balubal was one of the Lateral Entrants who underwent the Public Safety Officers Basic Course for Lateral Entrants and was awarded the Dr. Jose P. Rizal Academic Excellence Award last December 19, 2023 for having been graduated number one (1) in a class composed of fifty (50), garnering a grade of 95.388%.
5. P/Capt. Kristy Joy Beran Balubal is a resident of Barangay Dadda, Tuguegarao City who is the daughter of Mr. Calixto G. Balubal and Mrs. Enriqueta Babaran Balubal.
