UDANGA proudly represented Tuguegarao City in the said tournament, demonstrating exceptional skill, discipline and sportsmanship by competing in categories, including 10-11 years old Newbie Kumite, 11-14 years old Novice Team Kata, 11-14 Years Old Advance Team Kata, 11-14 years old Intermediate Team Kata, 10-11 years old Novice Kumite, 10-11 years old Novice Kata and 10-11 Years Old Open Kumite;

WHEREAS, CYRILLE FAITH D. UDANGA is a Grade 5 pupil of Tuguegarao West Central School, a resident of Atulayan Norte, Tuguegarao City and the daughter of Mr. Jan Meyrick A. Udanga and Mrs. Jaycee D. Udanga;



RESOLVED FURTHER, to furnish a copy of this Resolution to Cyrille Faith D. Udanga for information.


