The committee met and deliberated on the referral:

SUBJECT:

Indorsement of the City Mayor, Hon. Maila Rosario S. Ting-Que, on the request of Ms. Elizabeth G. Dupaya to hold hackfights (Ulután) on various dates for the month of March 2026.

FINDINGS:

1. Hon. Maila Rosario S. Ting-Que formally indorsed to the Tenth City Council the request of Ms. Elizabeth G. Dupaya seeking authority to conduct hackfights (Ulután) on various dates in March 2026.
2. Section 10, Paragraph (D) of City Ordinance No. 32-08-2019 provides that the City Mayor is authorized to issue permits for the conduct of special cockfights, cock or stag derbies, including cockfights via satellite, participated in by cockers and breeders through invitation, upon application duly approved by the Sangguniang Panlungsod through a resolution issued at least thirty (30) working days prior to the scheduled playdate.

The said ordinance further mandates that the authority to conduct special cockfights or derbies, as well as barangay-sponsored cockfights, shall at all times be covered by both a Resolution of the Sangguniang Panlungsod and a corresponding Mayor's Permit.

3. Section 4, Letter (f) of Presidential Decree No. 449 expressly provides that no form of gambling whatsoever shall be allowed within the premises of the cockpit or at any place where cockfighting is being conducted during cockfights.

4. As manifested by the representative of Dupaya Recreation Center, the requested hackfights (Ulután) with the purpose of providing cash support to the beneficiaries for the following mentioned dated below:
 - a. March 2, 2026- Prince Arjel Jesus Saltarin, 7 years old from Caritan Centro, diagnosed with Congenital Heart Failure.
 - b. March 9, 2026- Mr. Augusto Noel Gumabay from Linao Norte, diagnosed with Hypertension.
 - c. March 16, 2026- Mr. Emanuel Baxa, 64 years old from Atulayan, diagnosed with Schizophrenic Disorder.
 - d. March 23, 2026- Mr. Raffy Mendoza from Burgos Street, Tuguegarao City, Pulmonary Tuberculosis.
 - e. March 30, 2026- Mr. Fernando Azuri, 55 years old from Peñablanca Cagayan, diagnosed with Hypertension/Diabetes.
5. The Committee observed, based on the previous income statement of Dupaya Recreation Center, that the operation of the Hackfights incurred losses. However, in connection with their current request for approval to conduct Hackfights, the representative manifested that the expected assistance to the beneficiary shall be as follows:

If the operation incurs a loss or earns income up to ₱20,000, the amount of ₱2,000 shall be extended as assistance; and for every additional income bracket of ₱10,000 beyond ₱20,000, an additional ₱1,000 shall be given.
6. For purposes of proper monitoring and future reference, the Committee reiterated its directive requiring the Dupaya Recreation Center to consistently submit an Income Statement Report, a Documentation Report on the extension of support, the corresponding Acknowledgement Receipt, and a copy of the secured Special Permit from the Office of the City Mayor for each special cockfight event conducted.
7. The Committee likewise noted that one of the beneficiaries is a resident of Peñablanca, Cagayan. As confirmed by the representative, while the said beneficiary is from Peñablanca, Cagayan, he is an employee of the Dupaya Recreation Center.

For the meantime, the Committee considered the matter acceptable; however, moving forward, the representative was formally advised that the beneficiaries for the conduct of special derbies should be residents of Tuguegarao City.

8. The Committee reminded the Dupaya Recreation Center that prior to the conduct of regular and approved special cockfights, it must first ensure the renewal of its business permits.
9. The Committee recommends the approval of the requested schedules for the conduct of hackfights (Ulután) on March 2, 9, 16, 23 and 24, 2026, as these dates are found to be in compliance with Section 10 Paragraph D of the City Ordinance No. 32-08-2019.

RECOMMENDATION:

After thorough deliberation and upon finding the request to be in compliance with City Ordinance No. 32-08-2019, which governs the conduct of special cockfights, the Committee hereby recommends the approval of the request of Ms. Elizabeth G. Dupaya to conduct hackfights (Ulután) on March 2, 9, 16, 23, and 24, 2026.

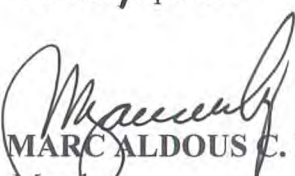
