#### SUBJECT:

WHEREAS, Section 22(c) of Republic Act No. 7160, otherwise known as the Local Government Code, grants the power to the Local Chief Executive to enter into contracts on behalf of the local government unit with prior authorization by the sangguniang panlungsod;

WHEREAS, the City Mayor, Hon. Maila Rosario S. Ting-Que, indorsed to the Ninth City Council the Deed of Donation between the Pangasinan Five Star Bus Co. Inc. and Tuguegarao City Government relative to the gratuitous transfer of the former's one (1) unit used passenger bus in favor of the latter;

WHEREAS, the City Mayor, requested the Ninth City Council to grant her an authority to sign for and on behalf of the Tuguegarao City Government the said Deed of Donation;

WHEREAS, the Pangasinan Five Star Bus Co. Inc. affirms that the donation of one passenger bus is not made with the intent to deceive creditors, and that sufficient funds and property have been reserved to meet its other obligations;

WHEREAS, the City Government of Tuguegarao hereby accepts and receives the donation made in its favour by the Pangasinan Five Star Bus Co. Inc., and hereby manifests its gratefulness for the latter's generosity;

**WHEREAS**, it is necessary for Pangasinan Fives Star Bus Co. Inc. to enter into a Deed of Donation with the Tuguegarao City Government to make the donation legally binding;

WHEREAS, after a deliberation in a committee meeting held for the said purpose, the joint Committee on Transportation as the lead Committee and Committee on Rules, Laws and Ethics found the request to be in order and beneficial to the constituents of Tuguegarao City;

**WHEREAS,** after the approval of the concomitant committee report, the Ninth City Council during its 121<sup>st</sup> Regular Session held on January 14, 2025 deemed it proper and necessary to approve the herein resolution.

**NOW, THEREFORE, RESOLVE** as it is hereby **RESOLVED** to approve the Deed of Donation between the Tuguegarao City Government and Pangasinan Five Star Bus and to grant authority to the City Mayor, Hon. Maila Rosario S. Ting-Que, to sign for and on behalf of the Tuguegarao City Government the said Deed of Donation.
