# COMMITTEE REPORT NO. 04-2025

#### **SUBJECT:**

Draft Ordinance amending City Ordinance No. 17-2002 Regulating Certain Activities Within the Premises of the Tuguegarao City Airport-sponsored by Hon. Bienvenido C. De Guzman II.

#### **ACTION TAKEN:**

The committee conducted a committee meeting last November 29, 2024 for the preliminary review of the herein subject with the presence of Hon. Bienvenido C. De Guzman II.

# FINDINGS:

1. Hon. Bienvenido C. De Guzman II sponsored a Draft Ordinance Amending City Ordinance No. 17-2002 Regulating Certain Activities Within the Premises of the Tuguegarao City Airport

- 2. The following were the amendments to the ordinance that were introduced:
  - a. Section 1 shall be read as "No kite or kites, pigeons, drone and balloons shall be flown or caused to be flown within the radius of **five (5) kilometers** from the center of the Tuguegarao City Airport.
  - b. Section 3 shall be read as "Any person who violates any provision of the Ordinance shall be punished not less than P5,000.00."
  - c. Remove Section 4.

Finding the herein proposed amended ordinance to be in order and meritorious, the joint committees favorably recommend the approval of an Ordinance Amending City Ordinance No. 17-2002 or the Regulation of Certain Activities Within the Premises of the Tuguegarao City Airport.

# AN ORDINANCE AMENDING SECTION 1 AND SECTION 3 AND DELETING SECTION 4 OF CITY ORDINANCE NO. 17-2002 TITLED "AN ORDINANCE REGULATING CERTAIN ACTIVITIES WITHIN THE PREMISES OF THE TUGUEGARAO CITY AIRPORT

#### Sponsor: Hon. Bienvenido C. De Guzman II

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that "Every Local Government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate incidental for its efficient and effective governance, and those who are essential to the promotion of the general welfare";

WHEREAS, Hon. Bienvenido C. De Guzman II sponsored a Draft Ordinance Amending City Ordinance No. 17-2002 Regulating Certain Activities within the Premises of the Tuguegarao City Airport which was included in the agenda of the 109<sup>th</sup> Regular Session of the Ninth City Council and was referred to the joint committee on transportation as the lead committee and Committee on Rules, Laws and Ethics;

WHEREAS, after a deliberation in a committee meeting held for the said purpose, the said Committees found the request to be in order and beneficial to the constituents of Tuguegarao City;

WHEREAS, after the approval of the concomitant committee report, the Ninth City Council during its 121<sup>st</sup> Regular Session held on January 14, 2025 deemed it proper and necessary to approve the herein ordinance.

NOW, THEREFORE, be it ORDAINED by the Sangguniang Panlungsod, in session assembled, to enact:

SECTION 1: TITLE This Ordinance shall be known as *ORDINANCE AMENDING SECTION 1 AND* SECTION 3 AND DELETING SECTION 4 OF CITY ORDINANCE NO. 17-2002 TITLED "AN ORDINANCE REGULATING CERTAIN ACTIVITIES WITHIN THE PREMISES OF THE TUGUEGARAO CITY AIRPORT.

#### **SECTION 2. AMENDMENTS:**

Section 1 and Section 3 of Ordinance No. 17-2002 shall be amended to read as follows:

Section 1. No kite or kites, pigeons, drone and balloons shall be flown or caused to be flown within the radius of five (5) kilometers from the center of the Tuguegarao City Airport.

Section 2. No person, vehicle or animals shall, without the permission from the Civil Aeronautics Administration Office, enter or loiter or be allowed to enter or loiter within the runway premises of the Tuguegarao City Airport and other designated areas thereof to which entry is prohibited by said Office.

Section 3. Any person who violates any provision of the Ordinance shall be punished not less than P5,000.00.

Section 4 of Ordinance No. 17-2002 below shall be deleted.

Section 4. For purpose of enforcement, the Air Transportation Office shall be deputized to implement the ordinance.

**SECTION 3. SEPARABILITY CLAUSE.** If for any reason, any provision of this Ordinance is declared invalid or unconstitutional, the remaining provisions not affected thereby shall remain and continue to be in full force and effect.

**SECTION 4. REPEALING CLAUSE.** Any and resolutions or ordinances or parts thereof not consistent with the provisions of this ordinance are hereby repealed.

SECTION 5. EFFECTIVITY CLAUSE. This Ordinance shall take effect upon its approval.
