CITY RESOLUTION NO. 41-10-2025

RESOLUTION ADOPTING AND APPROVING CITY DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (CDRRMC) RESOLUTION NO. 02-2025 RECOMMENDING THE LIFTING OF THE STATE OF CALAMITY IN TUGUEGARAO CITY DUE TO TYPHOON KRISTINE, AS RECOMMENDED BY THE CITY DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL

WHEREAS, the Ninth City Council in its Special Session held on October 28, 2024 approved City Resolution No. 601-09-2024 Declaring a State of Calamity in Tuguegarao City Due to the Damages Caused by Severe Tropical Storm Kristine;

WHEREAS, after a comprehensive assessment and evaluation conducted by the City Disaster Risk Reduction and Management Office (CDRRMO) and in coordination with concerned Barangays, it has been confirmed that the conditions that necessitated the declaration of a State of Calamity have significantly improved;

WHEREAS, the successful implementation of response and recovery programs, including the distribution of relief goods, utilization of the Quick Response Fund (QRF) and support to displaced families and affected communities, have led to the restoration of normalcy in the majority of the affected areas;

WHEREAS, the CDRRMC has recommended the lifting of the State of Calamity in Tuguegarao City effective January 20, 2025;

WHEREAS, the City Mayor, Hon. Maila Rosario S. Ting-Que, has indorsed to the Tenth City Council CDRRMC Resolution No. 02-2025 Recommending the Lifting of the State of Calamity in Tuguegarao City Due to Typhoon Kristine, as Recommended by the City Disaster Risk Reduction and Management Council (CDRRMC) for information and appropriate action;

WHEREAS, the Tenth City Council in its 5th Regular Session held on July 30, 2025 recommended to adopt and approve the said CDRRMC Resolution;
