WHEREAS, the Civil Service Commission has promulgated Resolution No. 25000358 titled *2025 Omnibus Rules on Appointments and Other Human Resource Actions* in order to establish a career service and adopt measures to promote morale, efficiency integrity, responsiveness, progressiveness and courtesy in the civil service;

WHEREAS, Rule IX of the said Resolution enjoins the creation of the Human Resource Merit Promotion and Selection Board at all levels, tasked to assess the competency of applicants and determine their qualifications based on the qualification standards set forth by the Commission;

WHEREAS, the City Mayor, Hon. Maila Rosario S. Ting-Que, has indorsed to the Tenth City Council her request for the adoption of a resolution on the creation of the Human Resource Merit Promotion and Selection Board of the Tuguegarao City Government;



