


**RESOLVED FURTHER**, to furnish a copy of this Resolution to Hon. Maria Rosario B. Soriano for her information.



On motion of Hon. Mangada and without any objection, **CITY RESOLUTION NO. 46-10-2025** was **APPROVED** under suspended rules.
