WHEREAS, Section 23 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides among other things that "the local chief executive may, upon authority of the Sanggunian, negotiate and secure financial grants or donations in kind, in support of the basic services or facilities enumerated under Section 17 hereof, from local and foreign assistance agencies without necessity of securing clearance or approval therefor from any department agency, or office of the national government or from any higher local government unit;"
