RESOLUTION MANIFESTING SUPPORT BY THE TENTH CITY COUNCIL OF TUGUEGARAO CITY TO THE LIST OF PROJECTS OF THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) UNDER THE CATEGORY OF CONDITIONAL IMPLEMENTATION UNDER FY 2025 GENERAL APPROPRIATIONS ACT (GAA)

WHEREAS, pursuant to Section 458 (a)(1) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlungsod is empowered to enact ordinances, approve resolutions, and appropriate funds for general welfare of the City and its inhabitants, in accordance with existing laws;

WHEREAS, the Department of Public Works and Highways (DPWH) is implementing various infrastructure projects aimed at enhancing mobility, accessibility, disaster resilience, and overall socioeconomic development across the country;

WHEREAS, the DPWH transmitted a letter dated July 03, 2025 stating that specific requirements must be met to facilitate the release of funds for new appropriations categorized as Conditional Implementation in compliance with the provisions of FY 2025 General Appropriations Act and the guidelines under the Department of Budget and Management National Budget Circular for the 2025 GAA;

WHEREAS, the Sangguniang Panlungsod recognizes the importance and potential benefits of these infrastructure projects in addressing urgent needs in road improvement, drainage, flood control, bridges, and vital public works within the jurisdiction of the city;

**WHEREAS**, the Tenth City Council would like to express its support to the realization of these projects, provided that all legal, technical, and environmental requirements are complied with;
