**CITY RESOLUTION NO. 53-09-2025**

**RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT BETWEEN THE TUGUEGARAO CITY GOVERNMENT AND THE PHILIPPINE STATISTICS AUTHORITY RELATIVE TO THE IMPLEMENTATION OF THE REVISED BATCH REQUEST SYSTEM (BREQS) AND GRANTING AUTHORITY TO THE CITY MAYOR, HON. MAILA ROSARIO S. TING-QUE, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID MOA**

**WHEREAS**, the Philippine Statistics Authority, through the Civil Registry System Information Technology Project (CRS-ITP), has established On-Line Civil Registry System (CRS) Outlets in various locations of the Philippines to serve as service points for the decentralized servicing of requests for Civil Registry Documents (CRDs) from the public;

**WHEREAS**, the Tuguegarao City Government, through the office of the City Civil Registrar, as part of its mandate, receives request for issuance of CRDs registered in the city;

**WHEREAS**, the Tuguegarao City Government is interested in providing a more extensive service to its constituents relative to the vital events (i.e., Birth, Marriage, and Death) and documents registered in the city including those that may have been registered in other localities;

**WHEREAS**, the Philippine Statistics Authority developed the BATCH REQUEST SYSTEM (BREQS) known as “BREQS”, a system to be used by the Tuguegarao City Government which provides an off-line method of encoding request for CRDs and submission thereof to a on-line CRS Outlets of the Philippine Statistics Authority;

**WHEREAS**, the use of BREQS will enable the Tuguegarao City Government to benefit from the CRS-ITP by providing a facility where its constituents can secure copies of CRDs issued by a CRS Outlet;

**WHEREAS**, there is a need for the passage of a resolution granting authority to the City Mayor, Hon. Maila Rosario S. Ting-Que, to sign for and on behalf of the Tuguegarao City Government the said MOA;


**WHEREAS**, upon the evaluation of the subject referral, the Committee on Rules, Laws and Ethics recommends for the adoption and approval of the Memorandum of Agreement and the granting of authority to the City Mayor to sign for and on behalf of the Tuguegarao City Government the said MOA.

**NOW, THEREFORE, RESOLVE**, as it is hereby **RESOLVED**, to approve the Memorandum of Agreement between the Tuguegarao City Government and the Philippine Statistics Authority relative to the implementation of the revised Batch Request System (BREQS) and to grant authority to the City Mayor, Hon. Maila Rosario S. Ting-Que, to sign for and on behalf of the Tuguegarao City Government the said MOA.


On joint motion, **CITY RESOLUTION NO. 53-09-2025** was **APPROVED**.
