The joint committees met and deliberated on the referral:

**COMMITTEE REPORT NO. 55-2024.**

**SUBJECT:**

Indorsement of the City Mayor, Hon. Maila Rosario S. Ting-Que on the Resolution of the Barangay of Caritan Norte requesting to conduct of "Perya and Pa-Bingo ng Barangay" for celebration of Fiesta, for information and appropriate action.

## **FINDINGS:**

1. Hon. Maila Rosario S. Ting-Que indorsed to the Ninth City Council the Resolution of Barangay of Caritan Norte requesting to conduct of “Perya and Pa-Bingo ng Barangay” for celebration of Fiesta.
2. Barangay Caritan Norte enacted a resolution approving the application to operate a perya starting February 09 to March 25, 2024 from 6 PM to 10 PM.
3. Pa-Bingo ng Barangay will operate for one day only before its Barangay Fiesta.
4. The Barangay sought for the assistance of the PNP personnel to secure and ensure the public safety of the vicinity;
5. The Sangguniang Barangay has the power to exercise their power, duties and functions as mandated by the law.
6. The conduct of Perya and Pa-Bingo of the herein barangay will be a fund raising in order to financially support the different programs and activities for the general welfare of the constituents of the barangay.

## **RECOMMENDATIONS:**

After thorough discussions, the joint committees recommend the approval of the conduct of “Perya” and advised the Punong Barangay of Caritan Norte to strictly observe the following;

1. To maintain cleanliness and sanitation within the premises;
2. To secure and ensure the safety of the vicinity by providing security personnel;
3. To strictly comply to City Ordinance No. 12-09-2023, *An Ordinance Imposing Curfew Hours for Minors to Prevent Juvenile Delinquency and Providing Penalties thereof; with the exemption provided under Section 5 (3) Minors who are in the company of their parents, guardians and proper authorities;* and
4. To strictly observe health protocols within the premises.
5. Any form of illegal gambling activity, such as: Drop Ball, 6/8, Color Game and other similar illegal gambling activities inside the carnival shall be a ground for the termination/stoppage of their operation and revocation of their business permit.

The joint committees further recommend the approval of the conduct of “Pa-Bingo ng Barangay” subject to the requirements setforth by the other agencies.

## MEMORANDUM OF AGREEMENT

Know All Men By These Presents:

This Memorandum of Agreement is made and execute by and in between:

**BARANGAY CARITAN NORTE, TUGUEGARAO CITY, CAGAYAN**, herein represented by its Barangay Captain, **FELIX T. TAGUIAM, JR.** of legal age, Filipino citizen, married and a resident of Caritan Norte, Tuguegarao City, Cagayan, hereinafter referred to as the **FIRST PARTY**;

**FMQ AMUSEMENT**, herein represented by its owner **MARYFLOR QUERUBIN LLAGAS**, of legal age, Filipino citizen, married and a resident of Balzain East, Tuguegarao City, Cagayan, hereinafter referred to as the **SECOND PARTY**.


### WITNESSETH :

**WHEREAS**, the **FIRST PARTY** shall conduct its annual fiesta specifically every 18<sup>th</sup> and 19<sup>th</sup> day of March, in honor Saint Joseph, the Barangay Patron;

**WHEREAS**, the Barangay Council of Barangay Caritan Norte, herein represented by their Barangay Captain, has agreed and to put up an amusement "PERYA" which is also evidenced by a Barangay Resolution No. 14-Series of 2024, affirming the putting up of a "PERYA";

**WHEREAS**, the **SECOND PARTY** has offered their services to the **FIRST PARTY** in beginning February 09, 2024 to March 25, 2024,

**WHEREAS**, the **SECOND PARTY** shall only operate every 6:00 P. M up to 10:00 P.M. daily during the said contract period;



**WHEREAS**, the **SECOND PARTY** has also agreed the contract fee in the total amount of TWENTY THOUSAND PESOS (Php. 20,000.00) for the entire duration of this contract, and on which the **FIRST PARTY** shall acknowledge in writings or in any form of acknowledgement receipt;


**WHEREAS**, **SECOND PARTY** shall agree in the following rules and regulations, to wit: a) **SECOND PARTY** shall abide in the Republic Act No. 9003 otherwise known as "AN ACT PROVIDING FOR AN ECOLOGICAL SOLID WASTE MANAGEMENT PROGRAM"; b) **SECOND PARTY** shall abide in the Tuguegarao City Ordinance No. 04-09-2023; c) **SECOND PARTY** shall abide to all other Tuguegarao City and Barangay Caritan Norte Ordinances; d) **SECOND PARTY** shall operate the following amusement games, to wit: MINI BINGO, SHOOTING GALERY, TRAMPOLINE and DROP BALL (PINGPONG);

NOW THEREFORE, the FIRST PARTY and the SECOND PARTY have agreed as they do so agreed, to the above stipulated terms and conditions of the foregoing contract, and shall remain in force unless both party shall agree for an amendments.




