SUBJECT:

Indorsement of the Local Finance Committee on the following Barangay/SK Annual Budgets for CY 2025:

- a. Annual Budget for CY 2025 of Barangay Tagga in the amount of P4,009,534.00;
- b. Annual Budget for CY 2025 of Barangay Linao Norte in the amount of P6,517,470.00;
- c. SK Annual Budget for CY 2025 of Barangay Linao East in the amount of P1,059,303.00;
- d. SK Annual Budget for CY 2025 of Barangay Pengue-Ruyu in the amount of P1,026,582.00;
- e. SK Annual Budget for CY 2025 of Barangay Dadda in the amount of P375,800.00;
- f. SK Annual Budget for CY 2025 of Barangay Carig Norte in the amount of P518,530.70;

FOR THE PRESIDING OFFICER:

FINDINGS:

3. The members of the Committee concurred that the referred Barangay Annual Budgets for CY 2025 of Tagga, Linao Norte and SK Annual Budgets for CY 2025 of Linao East, Pengue-Ruyu, Dadda, Carig Norte and Cataggaman Viejo have complied with the following:
 - a. The appropriations are not in excess of the estimates of income duly certified as collectibles (Certified Statement of Income);
 - b. The Barangay and SK Budgets for CY 2025 of the referred Barangays have complied with the General Limitations and established budgetary requirements as certified by the Local Finance Committee.
