SUBJECT:

Letter of Punong Barangay of Cataggaman Pardo, Hon. Ronald B. Bucayu, on Barangay Ordinance No. 1-2024 Prohibiting Stray Animals from Roaming or Wandering within the Territorial Jurisdiction of Barangay Cataggaman Pardo, Tuguegarao City and Providing Penalties for Violation Thereof.

FOR THE PRESIDING OFFICER:

The Members of the Joint Committees met and deliberated on the Letter of Punong Barangay of Cataggaman Pardo, Hon. Ronald B. Bucayu, on Barangay Ordinance No. 1-2024 Prohibiting Stray Animals from Roaming or Wandering within the Territorial Jurisdiction of Barangay Cataggaman Pardo, Tuguegarao City and Providing Penalties for Violation Thereof. The Joint Committees respectfully submit the herein Committee Report and has the honor to report to this August body in session the following actions taken, its findings and recommendations.

ACTIONS TAKEN:

The joint committees conducted a thorough and wholistic evaluation on the Letter of Punong Barangay of Cataggaman Pardo, Hon. Ronald B. Bucayu, on Barangay Ordinance No. 1-2024 Prohibiting Stray Animals from Roaming or Wandering within the Territorial Jurisdiction of Barangay Cataggaman Pardo, Tuguegarao City and Providing Penalties for Violation Thereof on February 10, 2025.

Resource Persons were present to assist the joint committees in the committee deliberation.

FINDINGS:

- 1) Barangay Cataggaman Pardo requested from the Sangguniang Panlungsod the approval of Barangay Ordinance No. 1-2024 Prohibiting Stray Animals from Roaming or Wandering within the Territorial Jurisdiction of Barangay Cataggaman Pardo, Tuguegarao City and Providing Penalties for Violation Thereof.
- 2) The joint committees found out that there are already existing City Ordinances relative to the Prohibition of Stray Animals from Roaming or Wandering within the Territorial Jurisdiction of Tuguegarao City specifically stating the imposition of fees and penalties which are already incorporated in Section 3I.02 and 3I.05 of City Ordinance No. 07-2011 titled “*An Ordinance Enacting the Revenue Code of Tuguegarao City*”, to wit:

Section 3I.02 Imposition of Fee. There shall be collected the following poundage fees on each head from the owner of an astray animal found running or roaming at large in public or private places:

| a) Large Cattle | 1,000.00 /head |
| b) All other animals | 200.00 /head |

Section 3I.05 Penalty. Owners whose animals are caught astray and incurring damages to plants and properties shall pay the following fines:

| a) For the first offense | 500.00 |
| b) For the second offense | 1,000.00 |
| c) For the third and each subsequent offense | 2,000.00 |

In addition to the fine, the owners shall also pay the amount of damage incurred, if any, to the property owner.

RECOMMENDATIONS:

After a thorough discussion on the subject matter, the joint committees hereby recommend the following, to wit:

- 1. That Barangay Cataggaman Pardo shall adopt the provisions of City Ordinance No. 07-2011 titled “*An Ordinance Enacting the Revenue Code of Tuguegarao City*” specifically **Section 3I.02 Imposition of Fee and Section 3I.05 Penalty.**

2. That Barangay Cataggaman Pardo shall come up with a Resolution Strongly Adopting and Implementing City Ordinance No. 06-2003 titled "*An Ordinance Establishing a City Pound*"


