**WHEREAS**, Section 1 of City Ordinance No. 43-08-2022 titled *An Ordinance Amending Sections 17, 22, 23 and 26, Chapter IV and Sections 2.3 and 2.5 of the Contract of Lease of City Ordinance No. 23-2018, otherwise known as the "Amended Tuguegarao City Market Code of 2005"* provides the composition of the Market Committee;

**WHEREAS**, on January 16, 2024, during its 74<sup>th</sup> Regular Session, the Ninth City Council held its election for this purpose;


