**WHEREAS**, Republic Act No. 9262, otherwise known as the “Anti-Violence Against Women and their Children Act of 2004,” mandates the protection of women and children from violence, including Intimate Partner Violence (IPV), and encourages multi-sectoral collaboration to prevent abuse and support survivors;

**WHEREAS**, Cagayan State University (CSU) is a gender-responsive institution committed to the attainment of gender equality and the empowerment of both men and women in delivering world-class

education. It promotes sustainable development and fosters a socially responsible environment that is free from all forms of injustice;

**WHEREAS**, the research titled “Breaking Cycles of Abuse: Empowering Women Through a Primary Support Program and Advocacy Intervention in Intimate Partner Violence,” conducted in 2023 and completed in May 2024, analyzed intimate partner violence (IPV) cases filed with the Philippine National Police – Tuguegarao Component City Police Station (PNP-TCCPS) from 2016 to 2024;

**WHEREAS**, the said research is the result of the concerted efforts of Dr. Chona P. Agustin, Lead Researcher, and team members Ms. Marygrace T. Delelis, Ms. Catherine F. Gizon and Ms. Julia T. Cardona, all of whom are faculty members of Cagayan State University;

**WHEREAS**, the Tuguegarao City Government recognizes the importance of collaboration with various line agencies and stakeholders, especially the academe;

**WHEREAS**, the Tuguegarao City Government acknowledges the significance of the research conducted by CSU and sees the need to enter into a Memorandum of Agreement (MOA) for the implementation of the research program and its proposed activities related to intimate partner violence (IPV);

**WHEREAS**, the efforts of the researchers significantly contribute to the city’s understanding of IPV trends and the development of more responsive policies and interventions, thereby supporting the city’s commitment to protecting women and promoting a violence-free community;




