**RESOLUTION RECALLING CITY RESOLUTION NO. 45-09-2025 APPROVING THE
REQUEST FOR RECONSIDERATION OF THE TUGUEGARAO GAME FOWL BREEDERS,
DUPAYA COCKPIT EMPLOYEES AND DUPAYA GAFFERS ASSOCIATION RELATIVE
TO THE APPLICATION OF DUPAYA RECREATION CENTER, INC. FOR
SPECIAL DERBIES TO BE CONDUCTED MONDAYS AND WEDNESDAYS
FOR THE MONTHS OF JANUARY AND FEBRUARY 2025**

WHEREAS, the Ninth City Council in its 121st Regular Session held on January 14, 2025 approved City Resolution No. 45-09-2025 titled *Resolution Approving the Request for Reconsideration of the Tuguegarao Game Fowl Breeders, Dupaya Cockpit Employees and Dupaya Gaffers Association Relative to the Application of Dupaya Recreation Center, Inc. for Special Derbies to be Conducted Every Mondays and Wednesdays for the Months of January and February 2025*;

WHEREAS, the said resolution was the subject of discussion under Information and Other Matters during the 122nd Regular Session held on January 21, 2025 when Hon. Baccay brought out the legality of the said resolution stating that a resolution cannot supersede an ordinance;

WHEREAS, in the discussion, emphasis was placed on Section 10(D) of City Ordinance No. 32-08-2019 which states that *“the City Mayor may issue permits for special cockfights, cock or stag derbies including cockfights via satellite participated in by cockers and breeders through invitations upon application duly approved by the Sangguniang Panlungsod through resolution of 30-working days before the scheduled playdate;”*

WHEREAS, it was found out that the playdates on January 15, 20, 22, 27 and 29, 2025 and February 3, 5, 10, 12, 17, 19, 22 and 26, 2025 are beyond the 30-working days as stated in the said city ordinance, hence, the recall of the City Resolution No. 45-09-2025.




