WHEREAS, the LCP held its 75th General Assembly at Conrad Manila in Pasay City on August 8, 2025;

WHEREAS, during the said assembly, Hon. Maila Rosario S. Ting-Que, Mayor of Tuguegarao City, was elected as Deputy Public Relations Officer for Luzon of the League of Cities of the Philippines (LCP);

WHEREAS, the achievement of City Mayor Hon. Maila Rosario S. Ting-Que and the trust and confidence bestowed upon her by other city mayors in the entire Philippines reflect her true dedication, competence and commitment to genuine public service, making her a role model and inspiration for her fellow Tuguegaraoños and is, therefore, worthy of recognition and commendation;



RESOLVED FURTHER, to furnish a copy of this Resolution to the City Mayor, Hon. Maila Rosario S. Ting-Que, for her information.


On motion of Hon. Bayona and without any objection, **CITY RESOLUTION NO. 70-10-2025** was **APPROVED**.
