**FINDINGS and RECOMMENDATION:**



However, the members of the committee just made some suggestions for the improvement of their Internal Rules of Procedure, which were duly noted by the Punong Barangay.

The committee recommends to copy furnish the concerned barangay with the committee report for their information.


