COMMITTEE REPORT NO. 073-2024

SUBJECT:

Indorsement of the City Mayor, Hon. Maila Rosario S. Ting-Que, requesting for an authority to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement in the implementation of the Bayanihan Program.

FINDINGS:

1. The City Government has come up with a sustainable Bahayanihan Project to provide disaster-resilient units for its inhabitants every year.

- 2. The City Government leads its way forward of bringing back the BAHAYANIHAN SPIRIT among capable agencies to help build homes for deserving families. It gives essence to camaraderie and unity towards building stronger community and a heartfelt service dubbed as "Serbisyong Nakikita, Nadarama, at Maasahan."
- The City Social Welfare and Development Office shall identify the recipients based on its Data Profiling System, conduct social preparation, monitoring and evaluation of the project.
- 4. The City Government shall provide the funds for the project implementation amounting to Two Hundred Thousand Pesos (Php 200,000.00) per housing unit with a floor area of 4 meters by 5 meters concrete bungalow house.
- 5. The manpower during the construction of the housing unit shall be augmented by the other line agencies listed as the Third Party.
- 6. As of 2023, there were already 32 house units constructed and distributed to qualified beneficiaries at the different barangays in the city with a total funds of ₱6.5M.

RECOMMENDATION:

After perusal of the Terms and Conditions of the Memorandum of Agreement particularly on the Roles and Responsibilities of the parties, the committees find the Memorandum of Agreement to be in order, with merit and beneficial to the City Government and its constituents, the committee favorably recommend for its approval.

The Committees further recommend for the passage of a Resolution granting authority to the City Mayor Hon. Maila Rosario S. Ting-Que to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement to be entered into by and between the Tuguegarao City Government, Beneficiary, PNP-Tuguegarao City CPOMPACT Police Station and Barangay Captain for the implementation of the Bahayanihan project.

WHEREAS, Section 455 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that the local chief executive shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance;

WHEREAS, pursuant to the herein provision, the Tuguegarao City Government continuously partner with other concerned government and non-government agencies to work hand in hand in order to constantly improve its programs to make them readily accessible to everyone for the general welfare of its people;

WHEREAS, in line with the call of the national government on the formulation of long term and sustainable programs and policies to support and facilitate housing projects to low-income earners and underprivileged families, the Tuguegarao City Government has come up with a sustainable Bahayanihan Project to provide disaster-resilient units for its inhabitants every year;

WHEREAS, in order to bring back the BAHAYANIHAN SPIRIT, the Tuguegarao City Government shall partner with capable agencies to help build homes for deserving families which gives an essence of camaraderie and unity towards building stronger community and a heartfelt service dubbed as "Serbisyong Nakikita, Nadarama, at Maasahan";

WHEREAS, the Tuguegarao City Social Welfare and Development Office shall identify the recipients of the project based on its Data Profiling System, conduct social preparation, monitoring and evaluation of the project;

WHEREAS, the Tuguegarao City Government shall provide the funds for the project implementation amounting to Two Hundred Thousand Pesos (Php 200,000.00) per housing unit with a floor area of 4 meters by 5 meters for concrete bungalow house;

WHEREAS, Hon. Maila Rosario S. Ting-Que indorsed to the Ninth City Council the said Memorandum of Agreement and requested for authority to sign for and on behalf of the Tuguegarao City Government the said MOA.

WHEREAS, the Ninth City Council during its regular session found the terms and conditions of the Memorandum of Agreement to be in order, with merit and beneficial to the constituents of the City.

NOW, **THEREFORE**, **RESOLVE**, as it is hereby **RESOLVED**, to approve the Memorandum of Agreement (MOA) to be entered into by and between the Tuguegarao City Government, Beneficiary, Philippine Nation Police (PNP)-Tuguegarao City COMPACT Police Station and Barangay Captain for the Implementation of the Bayanihan Project and grant authority to Hon. Maila Rosario S. Ting-Que, to sign for and on behalf of the Tuguegarao City Government the said MOA.
