# **COMMITTEE REPORT NO. 073-2025**

## SUBJECT:

Draft Resolution requesting the City Mayor, Hon. Maila Rosario S. Ting-Que, to grant Cash Incentives in the amount of One Hundred Thousand Pesos (P100,000.00) to Barangay Tanza, Cataggaman Nuevo, Capatan, Caritan Centro, San Gabriel, Centro 06 and Pengue-Ruyu, Tuguegarao City, Cagayan for being the National Passers in the 2024 Seal of Good Local Governance for Barangay (SGLGB).

# FINDINGS:

1. In recognition to the performance of the Seven (7) Barangays, Hon. Ronaldo S. Ortiz, Hon. Jude T. Bayona, Hon. Arnel T. Arugay and Hon. Restituto C. Ramirez sponsored Draft Resolution requesting the City Mayor, Hon. Maila Rosario S. Ting-Que, to grant Cash Incentives in the amount of One Hundred Thousand Pesos (P100,000.00) to Barangay Tanza, Cataggaman Nuevo, Capatan, Caritan Centro, San Gabriel, Centro 06 and Pengue-Ruyu, Tuguegarao City, Cagayan for being the National Passers in the 2024 Seal of Good Local Governance for Barangay (SGLGB).

- 2. The Seal of Good Local Governance for Barangay (SGLGB) is a performance assessment and recognition system that aims to give distinction to barangays with outstanding performance across various governance areas.
- This program of the Department of Interior Local Government (DILG) aims to encourage barangays to continuously progress in delivering efficient, equitable and quality public service.
- 4. DILG Memorandum Circular 2024-068 issued on May 8, 2024 states that a barangay unit needs to pass all of the three (3) Core Governance Areas and at least One (1) of the Essential Governance Areas in order to be an awardee to the 2024 Seal of Good Local Governance for Barangay (SGLGB).
- 5. Out of the several barangay units in the entire Philippines that Seal of Good Local Governance for Barangay (SGLGB) evaluated, seven (7) barangays of Tuguegarao City have satisfactorily passed the assessment indicators, thus achieving the national passers status.
- 6. In recognition for their remarkable performance, the Tuguegarao City Government deems it proper to give incentives and rewards to the seven (7) barangays which were national passers in the Seal of Good Local Governance for Barangay for CY 2024.
- 7. Ms. Luthgarda Bingcang, Budget Officer manifested that a total of P700,000.00 for the cash incentives of the seven (7) barangays will be considered as one of the items for Supplemental Budget if the retained earnings is sufficient and she further informed that during election period, the City Government is only entitled to release two (2) quarters of the appropriations and in case funds is not sufficient, an augmentation process will follow.

WHEREAS, the Essential Governance Areas are assessment indicators which include in providing basic social welfare services, promoting business and income-generating activities, and safeguarding the environment.

WHEREAS, of the several barangay units in the entire Philippines that SGLGB has evaluated, seven barangays of Tuguegarao City have satisfactorily passed the assessment indicators, thus achieving the national passers status.

WHEREAS, in recognition for their remarkable performance in the pursuit of an accountable, transparent and responsive barangay governance that immensely contributed in the efficient and effective delivery of essential public services, the Tuguegarao City Government deems it proper to give incentive and rewards to the seven (7) barangays which were national passers in the Seal of Local Good Governance for Barangay for CY 2024.
