CITY RESOLUTION NO. 74-09-2024

RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT BETWEEN THE TUGUEGARAO CITY GOVERNMENT AND VISITING CONSULTANTS/SPECIALISTS FOR THE TUGUEGARAO CITY PEOPLE’S GENERAL HOSPITAL

WHEREAS, Section 22(c) of Republic Act No. 7160, otherwise known as the Local Government Code, grants the power to the Local Chief Executive to enter into contracts on behalf of the local government unit with prior authorization by the Sanggunian concerned;

WHEREAS, the referral “*Indorsement of the City Mayor, Hon. Maila Rosario S. Ting-Que, on the draft Memorandum of Agreement between the Tuguegarao City Government and new Visiting Consultants/Specialists of the Tuguegarao City People’s General Hospital*” was endorsed to the Ninth City Council;

WHEREAS, the Ninth City Council in its 19th Regular Session held on November 22, 2022 approved City Ordinance No. 61-09-2022 titled “*An Ordinance Granting Continuing Authority to the City Mayor for and on Behalf of the Tuguegarao City Government to Enter into a Memorandum of Agreement with Visiting Consultants/Specialists of Tuguegarao City People’s General Hospital*”;

WHEREAS, in order to make the contract legal binding, it is necessary to enter into a Memorandum of Agreement with the following Visiting Consultants/Specialists for the Tuguegarao City People’s General Hospital:

1. Dr. Necie H. Almonte – OB-Gynecologist
2. Dr. Joylyn M. Adduru - Pediatrics

WHEREAS, the services of the Consultants/Specialists are basic requirements for the continuous licensing of the clinical laboratory of the Tuguegarao City People’s General Hospital;

WHEREAS, upon review of the subject referral, the Ninth City Council during its 76th Regular Session held on January 30, 2024 found the MOA to be in order;

WHEREAS, the Body further recommended and decided during its deliberation in the plenary to include in the MOA the License Number and Registration Number of the Visiting Consultants/Specialists.

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to approve the Memorandum of Agreement between the Tuguegarao City Government and Visiting Consultants/Specialists for the Tuguegarao City People's General Hospital.
