SUBJECT:

Indorsement of the City Mayor, Hon. Maila Rosario S. Ting-Que, on the Council Resolution No. 01 series of 2023 of the Local Council for the Protection of Children entitled "Resolution Approving the Comprehensive Local Juvenile Intervention Program (CLJIP)

ACTION TAKEN:

The joint Committee Social Services and Committee on Rules, Laws and Ethics to which the matter was referred, met on February 13, 2024 to discuss the subject referral.

FINDINGS:

1. That pursuant to RA 9344 otherwise known as the Juvenile Justice and Welfare Act of 2006, as amended by RA 10630 (An Act Strengthening the Juvenile Justice System) it mandates all Local Government Units to Institute a Comprehensive Local Juvenile Intervention Programs (CLJIP) for Children-At-Risk and Children-In-Conflict with the-Law (CICL) for at least three (3) years.
2. The Local Council for the Protection of Children (CICL) has initiated the formulation of the three-year Comprehensive Local Juvenile Intervention Program and identified various programs and services in delinquency prevention up to the rehabilitation and reintegration of Children-At-Risk and Children-In-Conflict with the-Law.
3. The Seventh City Council in its 53rd Regular Session held on August 29,2017 approved City Ordinance No. 32-2017 title *“An ordinance Establishing Local Juvenile Intervention and Diversion Programs, Pursuant to the Provision of Juvenile and Welfare Act of 2006 (RA 9344), Providing Funds Therefore and for Other Purposes.”*
4. The Eight City in its 26th Regular Session held on January 13, 2020 in lieu of January 14, 2020 approved City Resolution No. 002-08-2020 titled *“A Resolution Adopting and Approving Local Council for the Protection of Children (LCPC) Resolution No. 1-2019 titled “Resolution Approving the Comprehensive Local Juvenile Intervention Program (CLJIP) 2019-2022”*
5. The Local Council for the Protection of Children passed and approved Council Resolution No. 01 series of 2023 *“Resolution Approving the Comprehensive Juvenile Intervention Program (CLJIP) 2023-2026 on December 19, 2023.*
6. There is a need to again formulate a 3-year program for CY 2023 to 2026 to cater services in delinquency up to rehabilitation.

RECOMMENDATION:







WHEREAS, Hon. Maila Rosario S. Ting-Que indorsed to the Ninth City Council the herein resolution of the Local Council for the Protection of Children.

WHEREAS, the Ninth City Council during its regular session found the terms and conditions of the Memorandum of Agreement to be in order, with merit and beneficial to the constituents of the City.
