CITY RESOLUTION NO. 75-09-2024

RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT BETWEEN TUGUEGARAO CITY GOVERNMENT AND CAGAYAN STATE UNIVERSITY ON THE PROPOSED CONDUCT OF A RESEARCH PROJECT TITLED “ATHLETICS COMPETENCY OF COACHES AND ATHLETES: INPUT FOR GRASSROOTS SPORT DEVELOPMENT PROGRAM FOR TUGUEGARAO COACHES AND ATHLETES”

WHEREAS, Article XIV, Section 19 (1) of the 1987 Philippine Constitution provides that "the State shall promote physical education and encourage sports programs, league competitions and amateur sports, including training for international competitions, to foster self-discipline, teamwork and excellence for the development of a healthy and alert citizenry";

WHEREAS, CSU, created by virtue of P.D. 1436, as the only higher educational institution in Region II offering academic programs in physical education and sports sciences, adheres unto the aforesaid constitutional mandate and commits to serve the community by crafting curricula which are responsive to individual and social needs and extending technical assistance and expertise through Instruction, Research, Extension and Production along themes on sports education and coaching, among others;

WHEREAS, pursuant to R.A. 6847, the Philippine Sports Commission (PSC) was established to carry out the constitutional mandate to encourage, promote and sustain the creation and establishment of local sports promotion and development councils composed of representatives who include local government officials, among others, who shall initiate, conduct and coordinate sports activities in their respective jurisdictions;

WHEREAS, the Tuguegarao City Government had been in constant collaboration with CSU for socio-cultural activities and sports activities of the city;

WHEREAS, there are numerous athletes and coaches in the city who possess talents and skills in their respective fields of sports and manifest great potential to win or have displayed strong qualities by winning in different levels of sports competitions in City Meet, CAVRAA Meet, Palarong Pambansa, International Sports Competitions and equivalent government and private sponsored athletic competitions;

WHEREAS, pursuant to its over-arching objective to promote the welfare of the Cagayano people, CSU through its Bachelor in Physical Education (BPEd) and Bachelor of Science in Exercise and Sports

Sciences (BSESS) Programs in the graduate and undergraduate levels, in collaboration with LGU — TUGUEGARAO CITY, intends to collaborate for the conduct of a research project titled, **Athletics Competency of Coaches and Athletes: Input for Grassroots Sport Development Program for Tuguegarao Coaches and Athletes** which shall serve as a precursor to an extension program with foci on sports training and coaching;

WHEREAS, the primary objective of the abovementioned project is to determine the current knowledge, skills and competencies of coaches and student-athletes in the city, along with their needs and concerns, with the end-goal of developing a logical framework for grassroots sports development program which shall be institutionalized and sustained through the collaborative efforts of the concerned stakeholders, thus harnessing the vast potential of the citizenry in sports and coaching and thereby making Tuguegarao City a sports powerhouse in Region II in the process;

WHEREAS, the joint committees found out that CSU is seeking assistance from the Tuguegarao City Government amounting to Three Hundred Twenty Thousand (P320,000.00) for the conduct of their research project titled “**Athletics Competency of Coaches and Athletes: Input for Grassroots Sport Development Program for Tuguegarao Coaches and Athletes**”;

WHEREAS, the City Legal Officer, Atty. Vanessa T. Herrero-Verbo, suggested the following during the meeting, to wit:

- a) that CSU shall specifically state the duration of the program in the MOA;
- b) that all terms and conditions regarding provision for extension to finish be reflected in the MOA;
- c) that in the 6th whereas clause the word “implementation” be replaced with the word “conduct”;
- d) that provisions on penalties and liabilities shall be included in the MOA; and
- e) that the provision as to Ownership of the Sports Development Program Research shall be included in the MOA.

WHEREAS, there is a need for the passage of a resolution granting authority to the City Mayor, Hon. Maila Rosario S. Ting-Que, to sign for and on behalf of the Tuguegarao City Government the said MOA;

WHEREAS, all other suggestions and recommendations made by the parties during the committee hearing are already incorporated in the MOA;


WHEREAS, upon the evaluation of the subject referred, the joint committees recommend for the adoption and approval of the Memorandum of Agreement and the granting of authority to the City Mayor to sign for and on behalf of the Tuguegarao City Government the said MOA;

NOW, THEREFORE RESOLVE, as it is hereby **RESOLVED**, to approve the Memorandum of Agreement between the Tuguegarao City Government and Cagayan State University on the proposed conduct of a research project titled “Athletics Competency of Coaches and Athletes: Input for Grassroots Sport Development Program for Tuguegarao Coaches and athletes” and to grant authority to the City Mayor, Hon. Maila Rosario S. Ting-Que, to sign for and on behalf of the Tuguegarao City Government the said MOA.
