CITY RESOLUTION NO. 76-09-2024

RESOLUTION APPROVING THE REQUEST OF MS. ELIZABETH G. DUPAYA, MANAGER OF DUPAYA RECREATION CENTER INC., TO HOLD SPECIAL DERBIES (PROMOTED BY ODIE BOY FAUSTO) ON MARCH 20 AND 27, 2024 ONLY AND DENYING THE APPROVAL OF THE REQUESTED SCHEDULE OF SPECIAL DERBIES ON MARCH 6 AND 13, 2024

WHEREAS, Hon. Maila Rosario S. Ting-Que, City Mayor, indorsed the request of Ms. Elizabeth G. Dupaya, Manager of Dupaya Recreation Center Inc., regarding the holding of special derbies (promoted by Odie Boy Fausto) on various dates of March 2024;

WHEREAS, pursuant to Section 10, Paragraph D of City Ordinance No. 32-08-2019 states that the City Mayor may issue permits for special cockfights, cock or stag derbies including cockfights via satellite participated in by cockers and breeders through invitations upon application duly approved by the Sangguniang Panlungsod through resolution 30 working days before the scheduled playdate;

WHEREAS, Presidential Decree 499, Section 3, Paragraph C states *“To remove and prevent excessive and unreasonable business operation and profit consideration in the management of cockpits and instead preserve Philippine customs and traditions to enhance our national identity.”*;

WHEREAS, as stated on the above Presidential Decree, the Dupaya Recreation Center Inc. must only use traditional betting during its derbies;

WHEREAS, after a discussion, the committee recommended the approval of the requested schedules of Special Derbies on March, 20 and 27, 2024 only;

WHEREAS, the committee did not consider the requested schedule to hold Special Derbies dated March 6 and 13, 2024 considering its violation on the above-stated provision of the Ordinance;

NOW, THEREFORE, RESOLVE, as it is hereby, **RESOLVED**, to approve the request of Ms. Elizabeth G. Dupaya, Manager of Dupaya Recreation Center Inc., to hold special derbies (promoted by


Odie Boy Fausto) on March 20 and 27, 2024 only and denying the approval of the requested schedule of special derbies on March 6 and 13, 2024.
