COMMITTEE REPORT NO. 76-2024

SUBJECT:

Indorsement of the City Mayor, Hon. Maila Rosario S. Ting-Que, on the request of Ms. Elizabeth G. Dupaya of Dupaya Recreation Center to hold Special Derbies on various dates of April 2024.

FINDINGS:

1. Hon. Maila Rosario S. Ting-Que indorsed to the Ninth City Council the request of the Dupaya Recreation Center to hold special derbies on the various dates of April 2024.
2. Section 10 Paragraph D of the City Ordinance No. 32-08-2019 states that the City Mayor may issue permits for special cockfights, cock or stag derbies including cockfights via satellite participated in by cockers and breeders through invitations upon application duly approved by the Sangguniang Panlungsod through resolution **30-working days** before the scheduled playdate.

3. Due to time constraint of the referral and approval of the request, only dates of April 22, 24 & 29 are not in violation of the above-stated provision of the Cockfighting Ordinance.
4. The Representative of the Dupaya Recreation Center, Inc. sought consideration to approve some of the affected schedule playdates which was communicated to the Office of the City Mayor last February 15, 2024 and was transmitted to the Sangguniang Panlungsod Secretariat Office last February 16, 2024, however, the referral to the proper committee was prolonged due to the cancelled 79th Regular Session for having No Quorum.
5. With the request of the representative of the Dupaya Recreation Center, Inc., some members of the council present during the committee deliberation manifested to give consideration for the approval of the following dates only:


April 03, 2024
April 10, 2024
April 17, 2024
April 24, 2024 &
April 29, 2024 only.
6. The Dupaya Recreation Center, Inc. should use traditional betting during its Special Derbies.

RECOMMENDATION:

After thorough discussions without any objection from the members of the committee on the requested consideration by the representative of the Dupaya Recreation Center, Inc., the committee recommends the conduct of special derbies on April 03, 10, 17, 24 & 29 only and subject to the final approval of the Ninth City Council in plenary.

Further, the committee did not approve the scheduled playdates of special derbies on April 01, 08, 15 & 22.

WHEREAS, Hon. Maila Rosario S. Ting-Que indorsed to the Ninth City Council the request of the Dupaya Recreation Center to hold special derbies on the various dates of April 2024;
