CITY RESOLUTION NO. 76-09-2025

RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT BETWEEN THE TUGUEGARAO CITY GOVERNMENT AND PHILIPPINE SCHOOL OF HEALTHCARE PROFESSIONS, INC. RELATIVE TO THE TRAINING PROGRAM AND GRANTING AUTHORITY TO THE CITY MAYOR, HON. MAILA ROSARIO S. TING-QUE, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID MOA

WHEREAS, Republic Act No. 7796, also known as the Technical Education and Skills Development Act of 1994 (TESDA Act), established the Technical Education and Skills Development Authority (TESDA) which is mandated to oversee and coordinate technical education and skills development programs, including caregiver training programs, to address the demands of both domestic and international markets;

WHEREAS, the Council approved City Ordinance No. 06-2008 titled "Ordinance Adopting the Rules and Regulations Governing the Affiliation of Schools, Universities and Training Centers Offering Nursing and Allied Medical Courses at the People's Emergency Hospital (PEH) and at the City Health Office (CHO);"

WHEREAS, the Department of Health is making available its hospitals and accredited government community health resources for the learning and training of students from health professionals' schools;

WHEREAS, the Tuguegarao City Government aims to continuously promote and enhance the skills and capabilities of its constituents by providing opportunities for education and training in various fields, including healthcare professions;

WHEREAS, the Philippine School of Healthcare Professions, Inc. is a duly recognized training institution by the TESDA with business and postal address at St. Anthony Compound, Zone 7, Carig Norte, Tuguegarao City, Cagayan;

WHEREAS, the Local Chief Executive, Hon. Maila Rosario S. Ting-Que, indorsed to the Ninth City Council the draft Memorandum of Agreement between the Tuguegarao City Government and the Philippine School of Healthcare Professions, Inc. relative to the training program;

WHEREAS, the Philippine School of Healthcare Professions, Inc. shall pay the fees of P100.00 per student per semester and Affiliation Fee of P20.00 per student per eight (8) hours;

WHEREAS, the Sangguniang Panlungsod recognizes the importance of its partnership in providing quality training and education to the citizens of Tuguegarao City, which is aligned with the city's development goals;

WHEREAS, the Committee on Health and Sanitation, to which the matter was referred, met on January 6, 2025 to discuss the subject referral with the presence of resource persons;

WHEREAS, there is a need for the passage of a resolution granting authority to the City Mayor, Hon. Maila Rosario S. Ting-Que, to sign for and on behalf of the Tuguegarao City Government the said MOA;

WHEREAS, upon evaluation of the subject referral, the committee recommended for the approval of the Memorandum of Agreement and the granting of authority to the City Mayor, Hon. Maila Rosario S. Ting-Que, to sign for and on behalf of the Tuguegarao City Government the said MOA.

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to approve the Memorandum of Agreement between the Tuguegarao City Government and the Philippine School of Healthcare Professions, Inc. and to grant authority to the City Mayor, Hon. Maila Rosario S. Ting-Que, to sign for and on behalf of the Tuguegarao City Government the said MOA.
