#### **COMMITTEE REPORT NO. 77-2025**

#### SUBJECT:

Indorsement of the City Mayor, Hon. Maila Rosario S. Ting-Que, on the request of the President of Goldsmith Gaming Corporation, Mr. Michielson L. Luakian, for a Resolution of No Objection (RONO)

#### FINDINGS:

- 1. Resolution of No Objection (RONO) was requested as part of the requirements of securing Business Permit/Mayor's Permit of Goldsmith Gaming Corporation for their operation of Electronic BINGO games at the 2<sup>nd</sup> floor., Unitop Bldg., Balzain Highway, Centro 11, Tuguegarao City.
- 2. The Request for RONO was due to the transfer of ownership from Timothy James G. Yang to Allan P. Conception and change of tradename from Upshot Leisure & Bar Corporation to Goldsmith Gaming Corporation.
- 3. As requested by the joint committee before the deliberation began, a Secretary's Certificate was presented showing that the Branch Head, Ms. Janice A. Juan is duly authorized to represent the Goldsmith Gaming Corporation in securing a Resolution of No Objection (RONO).
- 4. As per the authorized representative of Goldsmith Gaming Corporation and in accordance to the amendments of the regulatory manuals of Electronic Games, Bingo Games & Poker Games, a Letter of No Objection (LONO) from the City/Municipal Council, i.e. Council Resolution or Ordinance, stating its No Objection to the establishment and operation of a gaming site situated within its locality must be secured as prerequisite document in applying PAGCOR gaming license.

- 5. The resource person also presented the Articles of Incorporation and SEC Certificate of the corporation to the committee.
- 6. During the discussion, the joint committee manifested that the following documentary requirements must be completed before the issuance of Business Permit.
  - a. Philippine Amusement and Gaming Corporation (PAGCOR) Application Form for the establishment of gaming site.
  - b. Philippine Amusement and Gaming Corporation (PAGCOR) Regulatory Framework for the Issuance of gaming license for the establishment of gaming venues.
  - c. Philippine Amusement and Gaming Corporation (PAGCOR) Gaming License.
  - d. Lease of Contract of Goldsmith Gaming Corp.
  - e. Site Floor Plan
  - f. Locational Clearance of Decision on Zoning (City Planning & Development Office)
  - g. Certificate of Occupancy, Survey Verification Plan (City Engineering Office)
  - h. BIR Certificate of Registration
  - i. Mayor's Permit
- 7. The joint committee requested to furnish Sangguniang Panglunsod a copy of the Documents submitted to Business Permit and Licensing Office (BPLO) once completed.
- 8. That the management shall prioritize employment of qualified residents from Tuguegarao City.
- 9. That the gaming place be secured with utmost security.

#### RECOMMENDATION:

After thorough discussion and deliberation of the said matter, the joint committee favorably recommends the passage of a Resolution approving the subject request for a Resolution Of No Objection (RONO) as a pre-requisite requirement in the establishment and operation of an Electronic BINGO games at the 2<sup>nd</sup> Flr., Unitop Bldg., Balzain Highway, Centro 11, Tuguegarao City, subject however to compliance with the PAGCOR guidelines on the operation of Electronic Games and other National/Local Laws and Ordinances.

WHEREAS, Mr. Michael L.
