WHEREAS, pursuant to Section 458 (a)(1) of Republic Act No. 7160, otherwise known as the *Local Government Code of 1991*, the Sangguniang Panlungsod is empowered to enact ordinances, approve resolutions and appropriate funds for the general welfare of the City and its inhabitants, in accordance with existing laws;

WHEREAS, clinical laboratory services play an important role in the diagnosis, treatment, prevention and control of disease. Thus, it is imperative to have a clinical laboratory to generate accurate, precise and reliable laboratory test results in a timely manner in assuring the quality of patient care;

WHEREAS, the clinical laboratory will be beneficial for the general welfare and healthcare of the inhabitants of Tuguegarao City;

WHEREAS, the operation of the said Clinical Laboratory shall be subject to the direct supervision of the City Health Office;

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to authorize the operation of a Primary Clinical Laboratory with limited services in Tuguegarao City Health Center located at Main Avenue, San Gabriel, Tuguegarao City under the supervision of the City Health Office;

RESOLVED FURTHER, the Tuguegarao City Health Office will cater the needs of its constituents particularly Clinical Sections with the following diagnostic test:


