SUBJECT:

Five (5) Draft Resolutions Commending the National Topnotchers in the February 2024 Respiratory Therapist Licensure Examination

FINDINGS:

1. The Professional Regulation Commission (PRC) has released the results of the February 2024 Respiratory Therapist Licensure Examination conducted in different testing centers in the National Capital Region and the Cities of Baguio, Cagayan De Oro, Cebu, Davao and Zamboanga.
2. Out of the One Thousand Three Hundred Eighty Three (1,383) examinees, One Thousand Seventy Seven (1,077) have successfully passed the Respiratory Therapist Licensure Examination of which the following examinees from Cagayan State University are included in the list of the top 10:

3. Frances Marie B. Suyu, Divine Grace R. Anastacio, Mary Rose M. Tumbali , Nicole Angelee H. Binayug and Axcel Bryan D. Mauanay belong to the Bachelor of Science in Respiratory Therapy Batch Harinawa 2023 of the Cagayan State University.
  4. Cagayan State University-Andrews Campus was the Top 1 Performing Respiratory School nationwide for Six (6) consecutive years from 2017-2024 and has obtained a 100% student passing rate for the Respiratory Therapist Licensure Examination on 2015, 2016, 2018, 2023 and 2024;
  5. The topnotchers have recognized the selfless effort and contribution of their former Department Chair and now their Clinical Coordinator, Ma. Nancy Tabangcura-Martinez, RTRP, MPH.
  6. The City Government of Tuguegarao commends the noteworthy accomplishment of Frances Marie B. Suyu, Divine Grace R. Anastacio, Mary Rose M. Tumbali , Nicole Angelee H. Binayug and Axcel Bryan D. Mauanay for bringing pride and honor to the city.
  7. Documents as proof of their achievements were furnished to the committee.
