FINDINGS:

5. The city recognizes the importance of fostering international understanding and cooperation among the youth, and encourages their active involvement in nation-building;
6. The service and participation of ZACH XAVIER GUMABAY SINGSON as a representative of the Philippines in promoting collaboration among the Youth in Asia during the conference is worthy of recognition and emulation as a role model for the Youth of the City.

 - a. The conference was participated by Five Hundred Eighty Five (585) delegates from forty (40) different countries wherein Eighty Nine (89) delegates came from the Philippines.
 - b. Zach Xavier is a student leader of University of St. Louis.
 - c. He is also the Brgy. Treasurer of Atulayan Sur.
