**RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT (MOA)
BETWEEN THE TUGUEGARAO CITY GOVERNMENT AND UNIVERSITY OF CAGAYAN
VALLEY (UCV) RELATIVE TO THE RELATED LEARNING EXPERIENCE/PRACTICUM
OF ITS COLLEGE OF HEALTH STUDENTS AND GRANTING AUTHORITY TO
THE CITY MAYOR, HON. MAILA ROSARIO S. TING-QUE, TO SIGN FOR AND
ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID MOA**

WHEREAS, Section 22(c) of Republic Act No. 7160, otherwise known as the Local Government Code, grants the power to the Local Chief Executive to enter into contracts on behalf of the local government unit with prior authorization by the sangguniang panlungsod;

WHEREAS, In support to the endeavors of students studying Allied Health Courses in any school or university in Tuguegarao City, the Tuguegarao City Government allows students to undergo actual clinical experience at the City Health Office (CHO) and Barangay Health Stations (BHS) thereby helping them put to practice their learnings in school;

WHEREAS, The University of Cagayan Valley has requested the Tuguegarao City Government to accommodate its College of Health students for their Related Learning Experience/Practicum as part of their curriculum;

WHEREAS, It is necessary for University of Cagayan Valley to enter into a Memorandum of Agreement (MOA) with the Tuguegarao City Government to make the MOA legally binding;

WHEREAS, The partnership between the Tuguegarao City Government and UCV is guided by the Policies, Procedures and Guidelines of the Department of Health governing affiliation and training of students in Hospitals/Rural Health Units and other health agencies as contained in DOH-CHED Joint AO

No. 2013-0034 titled “*Policies and Guidelines on the Affiliation of Higher Education Institutions (HEIs) with Hospitals and other Health Facilities for the Training of students in Health Professional Education*”;

WHEREAS, The Affiliation Fee to be collected shall be included in the MOA and that all fees be paid to the City Treasurer’s Office, subject to future increases in accordance with Commission on Higher Education (CHED) guidelines;

WHEREAS, The City Mayor, Hon. Maila Rosario S. Ting-Que, indorsed to the Tenth City Council the above-stated MOA and requested for an authority to sign for and on behalf of the Tuguegarao City Government the said MOA;

WHEREAS, The Tenth City Council during its 30th Regular Session held on February 03, 2026 deemed it proper and necessary to approve the herein resolution;

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to approve the Memorandum of Agreement (MOA) between the Tuguegarao City Government and University of Cagayan Valley for the Related Learning Experience/Practicum of its College of Health students and to grant authority to the City Mayor, Hon. Maila Rosario S. Ting-Que, to sign for and on behalf of the Tuguegarao City Government the said MOA.

RESOLVED FURTHER, to furnish a copy of this Resolution to University of Cagayan Valley for information and proper action.
