SUBJECT:

Indorsement of the Local Finance Committee on the following Barangay/SK Annual Budgets for CY 2025:

- Annual Budget for CY 2025 of Barangay Ugac Sur in the amount of P14,300,000.00.
- Annual Budget for CY 2025 of Barangay Carig Norte in the amount of P5,500,307.00;
- Annual Budget for CY 2025 of Barangay Centro 07 in the amount of P3,310,000.00.

FOR THE PRESIDING OFFICER:

FINDINGS:
