**RESOLVED FURTHER**, to furnish a copy of this resolution to Dr. Cesar Matthew U. Madria for his information.


On motion of Hon. Arugay, duly seconded by Hon. Arago, **CITY RESOLUTION NO. 95-09-2024** was **APPROVED**.
