FOR THE PRESIDING OFFICER:

2. The Special Programs for Employment of Students (SPES) aims to help students from low-income families to finance their education while gaining work experience; as such, the program requires private and public sector employers to hire students as temporary employees during the summer break.
3. The PESO has 3 core services namely: Referral and Placement of Applicants, Labor Market Information and Career Development and Sports Program.


RECOMMENDATIONS:



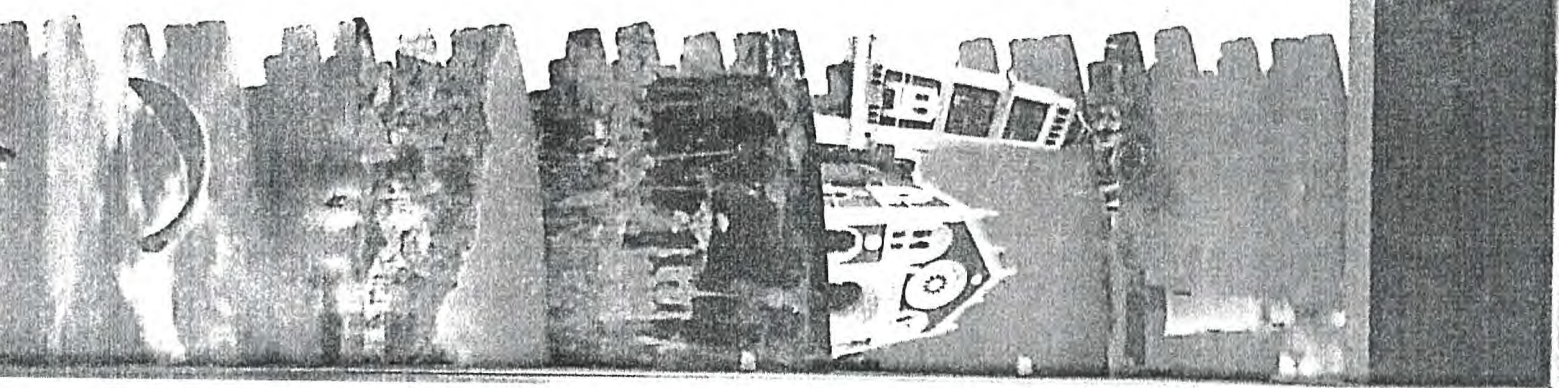
