The Committee met and deliberated on the referral:

SUBJECT:

"Indorsement of the City Mayor, Hon. Maila Rosario S. Ting-Que, on the request of Bishop Kenneth Cortez of the Church of the Living God-Philippines relative to the closure of Maggay Street corner Diciano Street to Stephen Street for the conduct of the National Youth Camp on April 16-20, 2025."

ACTION TAKEN:

The members of the Joint Committee met to discuss the subject matter with the presence of the resource persons.

FINDINGS:

- 1.) Hon. City Mayor Maila Rosario S. Ting-Que indorsed to the 9th City Council a letter from Bishop Kenneth Cortez of the Church of the Living God-Philippines requesting the closure of Maggay Street corner Diciano Street to Stephen Street for the conduct of the National Youth Camp on April 16-20, 2025.
- 2.) More than 3,000 young people from various CLG churches nationwide are expected to attend the National Youth Camp this year.
- 3.) Many vehicles are also expected to come in and out of the CLG compound during the activity.
- 4.) The City passed a similar ordinance last year declaring temporary road closure of the same subject street and activity where no untoward incidents were reported.
- 5.) Considering the safety of all participants and the community, and the nature of the event, there is a need to pass an ordinance for the temporary closure of the subject road during the said activity.

RECOMMENDATION:

Having thoroughly discussed the subject matter, the Joint Committee favorably recommends for the approval of an "Ordinance Declaring the Temporary Closure of Portion of Maggay Street Between Diciano Street and St. Stephen Street, Cataggaman Nuevo, Tuguegarao City, Cagayan on April 16-20, 2025 from 6:00 AM to 6:00 PM For The Conduct Of The National Youth Camp Of The Church Of The Living God", further recommending the following:

- 1. For the City Disaster Risk Reduction and Management Office (CDRRMO) to deploy standby rescue/medical team within the vicinity of the area;
- 2. For the TMG/PSSO to deploy enforcers who will assist in traffic management in the area, install signages, and to guide ambulant vendors who will engage business therein to not occupy the portion of the temporarily closed street;
- 3. For the City Environment and Natural Resources Office (CENRO) to schedule daily garbage collection in the area during the activity to ensure cleanliness and waste management;
- 4. For the City Information Office to disseminate advance information and notice to the public regarding the said road closure.

ORDINANCE DECLARING THE TEMPORARY CLOSURE OF A PORTION OF MAGGAY STREET BETWEEN DICIANO STREET AND ST. STEPHEN STREET, CATAGGAMAN NUEVO, TUGUEGARAO CITY, CAGAYAN ON APRIL 16-20, 2025 FROM 6:00 AM TO 6:00 PM FOR THE CONDUCT OF THE NATIONAL YOUTH CAMP OF THE CHURCH OF THE LIVING GOD

WHEREAS, pursuant to the pertinent provisions of Section 21 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Local Government Unit of Tuguegarao is authorized to temporarily close some of the local roads falling within its jurisdiction;

WHEREAS, the Church of the Living God (CLG) - Philippines will conduct its National Youth Camp on April 16-20, 2025 at the CLG Compound in Cataggaman Nuevo, Tuguegarao City, Cagayan;

WHEREAS, the said activity will be participated by more than three thousand (3,000) young people from the CLG Churches nationwide;

WHEREAS, the City Mayor, Hon. Maila Rosario S. Ting-Que, endorsed to the Ninth City Council the request of Bishop Kenneth Cortez of the Church of the Living God-Philippines requesting the closure of Maggay Street corner Diciano Street to Stephen Street for the conduct of the National Youth Camp on April 16-20, 2025 to ensure safety and security of all participants, and safer event logistics;

WHEREAS, the Ninth City Council in its 133rd Regular Session found the request to be proper and with merit, hence, recommended for its approval.

NOW, THEREFORE, be it **ORDAINED** by the Ninth City Council in session assembled to enact the following Ordinance:

SECTION 1. TITLE. This Ordinance shall be known as "City Ordinance Declaring the Temporary Closure of Portion of Maggay Street Between Diciano Street and St. Stephen Street, Cataggaman Nuevo, Tuguegarao City, Cagayan on April 16-20, 2025 from 6:00 AM to 6:00 PM For The Conduct Of The National Youth Camp Of The Church Of The Living God."

SECTION 2. SCOPE AND LIMITATION. This Ordinance shall cover a portion of Maggay Street between corner Diciano Street and corner St. Stephen Street, Cataggaman Nuevo as subject for closure to give way to the conduct of the said activity from 6:00 AM to 6:00 PM on April 16-20, 2025.

SECTION 3. INFORMATION. This Ordinance shall be disseminated through signages and all mass media outlets in the City including the Tuguegarao City Information Office.

SECTION 4. IMPLEMENTATION. The implementing agency shall be the Public Safety and Security Office (PSSO)/Traffic Management Group (TMG) in coordination with officials of Barangay Cataggaman Nuevo and the Tuguegarao Component City Police Station.

SECTION 5. STANDBY RESCUE TEAM. The City Disaster Risk Reduction and Management Office (CDRRMO) shall deploy standby rescue/medical team within the vicinity of the area during the activity.

SECTION 6. GARBAGE COLLECTION. The City Environment and Natural Resources Office (CENRO) shall schedule daily garbage collection in the area during the activity to ensure cleanliness and waste management.

SECTION 7. SEPARABILITY CLAUSE. If any provision or part of this Ordinance is declared invalid or unconstitutional, the remaining provisions shall not be affected and shall remain in full force and effect.

SECTION 8. REPEALING CLAUSE. All ordinances, resolutions, rules, and regulations inconsistent with this Ordinance are hereby repealed or modified accordingly.

SECTION 9. EFFECTIVITY. This Ordinance shall take effect on April 16-20, 2025.
