DRAFT RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE TUGUEGARAO CITY GOVERNMENT AND THE CAGAYAN STATE UNIVERSITY- CARIG CAMPUS (CSU) FOR THE PRACTICUM AND COMMUNITY EXTENSION OF BACHELOR OF SCIENCE IN EXERCISE AND SPORTS SCIENCES MAJORS IN FITNESS AND SPORTS MANAGEMENT (BSESS - FSM) AND FITNESS AND SPORTS COACHING (BSESS - FSC) STUDENTS AND GRANTING AUTHORITY TO THE CITY MAYOR, HON. MAILA ROSARIO S. TING-QUE, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID MOA

WHEREAS, Section 22 (c) of Republic Act No. 7160, otherwise known as the Local Government Code, grants the power to the Local Chief Executive to enter into contracts on behalf of the local government unit with prior authorization by the Sangguniang Panlungsod;

WHEREAS, in support to the endeavors of students studying in any school or university in Tuguegarao City, the Tuguegarao City Government allows students to undergo actual office experience thereby helping them put to practice their learnings in school;

WHEREAS, Cagayan State University- Carig Campus (CSU) has requested the Tuguegarao City Government for the Practicum and Community Extension of the following eight (8) Bachelor of Science in Exercise and Sports Sciences Majors in Fitness and Sports Management (BSESS - FSM) and Fitness Sports Coaching (BSESS - FSC) as part of their curriculum:

WHEREAS, it is necessary for Cagayan State University- Carig Campus (CSU) to enter into a Memorandum of Agreement (MOA) with the Tuguegarao City Government to make the MOA legally binding;

WHEREAS, the City Mayor, Hon. Maila Rosario S. Ting-Que, indorsed to the Ninth City Council the above-stated MOA and requested for an authority to sign for and on behalf of the Tuguegarao City Government the said MOA;

WHEREAS, after a deliberation in a committee meeting held for the said purpose, the Committee on Education found the request to be in order and beneficial to the concerned students;

WHEREAS, after the approval of the concomitant committee report, the Ninth City Council during their 82nd Regular Session held on March 12, 2024 deemed it proper and necessary to approve the herein resolution.

NOW, THEREFORE, RESOLVE as it is hereby **RESOLVED** to approve the Memorandum of Agreement (MOA) between the Tuguegarao City Government and the Cagayan State University- Carig Campus (CSU) for the Practicum and Community Extension of Bachelor of Science in Exercise and Sports Sciences Majors in Fitness and Sports Management (BSESS - FSM) and Fitness Sports Coaching (BSESS - FSC) students and to grant authority to the City Mayor, Hon. Maila Rosario S. Ting-Que, to sign for and on behalf of the Tuguegarao City Government the said MOA.

RESOLVED FURTHER, to furnish a copy of this Resolution to the Cagayan State University- Carig Campus (CSU), for information and proper action.

MEMORANDUM OF AGREEMENT

The "**CAGAYAN STATE UNIVERSITY**", created by virtue of Presidential Decree 1436, later amended by Republic Act 8292 by the integration of all publicly supported higher education institutions in the province of Cagayan, through its main campus at Andrews Campus, with official address at Caritan Sur, Tuguegarao City, 3500, Philippines, represented herein by its Campus Executive Officer, **ENGR. ROGER P. RUMPON.**, herein after referred to as "**FIRST PARTY**"

The "**TUGUEGARAO CITY HALL**", with office address at Carig Sur, Antonio street, Tuguegarao City, 3500, Philippines, represented herein by its City Mayor, **HON. MAILA ROSARIO S. TING-QUE** herein after referred as "**SECOND PARTY**".

WHEREAS, **FIRST PARTY**, recognizes COLLEGE OF HUMAN KINETICS (CHK) as the lead college of the University that provides programs, seminars, symposia and workshops on sports coaching and officiating and accreditation of coaches and technical officials in relevance to the realization of its flagship program which is Strengthening Sports Clinic;

WHEREAS, **SECOND PARTY**, acknowledges the need of a meaningful partnership with higher education institutions to enhance competency of BSESS program as stewards of fitness and sports in the community and effectively deliver to the different clienteles.

WHEREAS, **FIRST PARTY** and **SECOND PARTY** are willing to have their respective faculty/On-the-job trainees/employees to directly undertake a community work/extension program, and to provide each other with access to propriety teaching/on-the-job training/program materials;

WHEREAS, **FIRST PARTY** and **SECOND PARTY** will regularly share information about the On-the-job training's successes and barriers to success with the intent to improve programs and ensure the completion of the OJT.

NOW, THEREFORE, in consideration of the premises and mutual covenants herein contained, **FIRST PARTY** and **SECOND PARTY** agree as follows:

Section 1. PRACTICUM/ THE EXTENSION/FIELD VISIT/COMMUNITY WORK

Name of the Program: **INDUSTRY IMMERSION/ PRACTICUM**

Program Objectives:

- Provide opportunity to develop skills in coaching to highest possible level; and
- Update the coaches and trainers through scientific approach of designing training program suited for their athletes.

Reporting. The parties will generally keep one another informed of any status of the work(s), through the respective Program Coordinators.

Project Coordinators. The conduct of activities under this Agreement shall be under the direction of:

FIRST PARTY: Name: **GIOVANNI C. MORALES**
Designation: BSESS OJT Adviser

SECOND PARTY: Name: **HON. CITY MAYOR MAILA ROSARIO S. TING-QUE**
Designation: TUGUEGARAO CITY MAYOR

Section 2. TERMS AND TERMINATION

2.1 Term. This Agreement shall become binding upon execution by both parties. The term of this Agreement shall commence on _____ 20____ and shall end on _____ 20____, unless sooner terminated as permitted elsewhere herein.

2.2 Termination. Either party may terminate this Agreement sixty (60) days after written notice.

Section 3. ROLES AND RESPONSIBILITIES

FIRST PARTY will:

- collect necessary information from the employees of the **SECOND PARTY** as basis of the extension program and on-the-job training to be conducted;
- deploy faculty/students who will serve as the lecturer/s, on-the-job trainee/s and implementers of the on-the-job training ; and
- provide available sports equipment and facilities to facilitate the conduct of the activities of the **FIRST PARTY**.

SECOND PARTY will:

- provide necessary information for **FIRST PARTY** for the conduct of the program;
- ensure availability and active participation of staff/employees during set schedule of the program in order to maximize the assistance given by the implementers;
- ensure the availability of the sports equipment and facilities that shall be used in the different programs; and
- evaluate each program based on the criteria that will be given to the participants.

Section 4. DISSEMINATION

The **FIRST PARTY** has the right to publish and otherwise publicly disclose information derived from work conducted under this Agreement.

The **FIRST PARTY** and **SECOND PARTY** mutually agree to use the name of the other only in an accurate, factual, and descriptive manner, and only as they pertain to the terms of this MOA; and further agree not to use the name, logos, or trademarks of the other or the name of any staff member of either party in commercial or non-commercial advertising or promotion, or in any other manner, without the prior written permission of a duly authorized officer of the respective party and, in the case of a staff member, also the prior written permission of the staff member.
