WHEREAS, the Philippines has the most number of celebrations or feasts to commemorate an event for thanksgiving for the blessings bestowed upon the people and the area;

WHEREAS, almost all the barangays in the City of Tuguegarao City are celebrating their respective barangay fiestas annually;

WHEREAS, Barangay Cataggaman Nuevo, Tuguegarao City, Cagayan does not have its official festival name and date of its celebration;

NOW, THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED by the Sanggunian Barangay of Cataggaman Nuevo, Tuguegarao City, Cagayan, in its regular session duly assembled that:

Section 1. TITLE. This ordinance shall be known as **"AN ORDINANCE DECLARING THE CELEBRATION OF THE BARANGAY FIESTA OF BARANGAY CATAGGAMAN NUEVO, TUGUEGARAO CITY, ALSO KNOWN AS THE "TAGGAM FESTIVAL" TO BE HELD ANNUALLY ON THE 8TH DAY OF AUGUST."**

Section 2. RATIONALE, PURPOSE, AND INTENT OF THE ENACTMENT. With the national and local governments' bullish promotion and development of the tourism industry, festivals sprouted like mushrooms all over the country. Such festivals were usually held in celebration of the barangay governments' founding anniversary. However, Barangay Cataggaman Nuevo, Tuguegarao City, Cagayan does not have its official festival as well as the date of its celebration, a clear indication that barangay traditions and customs could never be downplayed. Hence, Barangay Cataggaman Nuevo, in full cooperation with the Local Government Unit of Tuguegarao City, Cagayan, designate August 08 every year as the official celebration of the "Taggam Festival", the barangay's festival. "Taggam Festival" derives its name from the *Itawes* term "Taggam," which means ant. The festival celebrates the rich cultural heritage and unity of the community, reflecting the characteristics of ants — hardworking, cooperative, and resilient. This name holds historical significance as it is also where the barangay got its name, symbolizing the values and spirit that define its people. The "Taggam Festival" has been selected as the name of the celebration to denote the unity and cooperation of the barangay mates in wholehearted participation in the promotion of barangay programs, projects, and activities geared towards advancement and prosperity.

Section 3. FUNDING. Funds shall be allocated annually by the Sangguniang Barangay and Sangguniang Kabatan (SK) to defray the expenses for the conduct of various activities during the celebration. It will be augmented by assistance coming from the local government and other agencies.

Section 4. REPEALING CLAUSE. All ordinances, rules, and regulations or parts thereof in conflict or inconsistent herewith are hereby repealed or modified accordingly.

Section 5. SEPARABILITY CLAUSE. If for any reason, any provision, section or any part of this ordinance is declared invalid by a court of competent jurisdiction or suspended or revoked by the Sangguniang Bayan, such judgment shall not affect or impair the remaining provisions, sections or parts hereof which shall remain and continue to be in full force and effect.


Section 6. EFFECTIVITY CLAUSE. This ordinance shall take effect fifteen (15) days after its posting at the barangay hall and at least two (2) conspicuous places in the barangay.

WHEREA, Section 384 of the same Code recognizes the barangay as the primary planning and implementing unit of government programs, projects, and activities in the community;

WHEREAS, The Department of the Interior and Local Government (DILG), through **Memorandum Circular No. 2024-053**, mandates all barangays nationwide to adopt and implement **Barangay Road Clearing Operations (BaRCO)** to maintain public roads, sidewalks, and alleys free from obstructions such as illegal structures and illegally parked vehicles;

WHEREAS, This initiative, in support of the **Bagong Pilipinas Program**, ensures public safety, efficient traffic flow, disaster preparedness, and the unhampered delivery of basic services;

WHEREAS, The Barangay of Cataggaman Nuevo recognizes its responsibility to adopt and enforce BaRCO through preventive, corrective, and community-based measures without imposing financial penalties on violators, but rather through **mandatory written warnings and community service**;

NOW, THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED by the Sangguniang Barangay of Cataggaman Nuevo, Tuguegarao City, Cagayan, in its regular session duly assembled that:

Section 1. TITLE. This Ordinance shall be known as the **"Barangay Road Clearing Operations (BaRCO) Ordinance of Cataggaman Nuevo."**

Section 2. IMPLEMENTATION AND ADOPTION.

The Barangay hereby formally adopts and implements in full DILG Memorandum Circular No. 2024-053 mandating continuous Barangay Road Clearing Operations (BaRCO).

Section 3. COVERAGE.

This Ordinance shall apply to all public roads, sidewalks, alleys, and other public spaces within the territorial jurisdiction of Barangay Cataggaman Nuevo.

Section 4. PROHIBITED ACTS.

The following acts are prohibited in public roads, sidewalks, alleys, and other public spaces:

- a. Construction or maintenance of illegal structures;
- b. Obstruction caused by debris, construction materials, or personal property;
- c. Unauthorized vending or occupation of sidewalks, alleys, and roadways;

- d. Parking of vehicles in prohibited areas or in a manner that blocks passage;
- e. Any activity that obstructs the free passage of pedestrians or vehicles.

Section 5. ENFORCEMENT MEASURES.

- a. The **Barangay Road Clearing Team**, composed of Barangay Officials, SK Officials, Tanods, and designated volunteers, shall implement and enforce this Ordinance.
- b. Any violator shall first be issued a **Mandatory Written Warning** directing the removal of obstruction within **48 hours**.
- c. In case of repeated violation or refusal to comply, the violator shall be required to render **community service**, such as **clean-up drives or similar activities** within the barangay, as determined by the Sangguniang Barangay.

Section 6. MONITORING AND REPORTING.

The Barangay shall conduct regular inspections and submit compliance reports on road clearing operations to the City Government of Tuguegarao and the DILG, in accordance with BaRCO's assessment and validation requirements.

Section 6. SEPARABILITY CLAUSE.

If any part of this Ordinance is declared invalid, the remaining provisions shall not be affected and shall remain in full force and effect.

Section 7. EFFECTIVITY.

This Ordinance shall take effect immediately upon approval and compliance with the posting and publication requirements prescribed by law.





WHEREAS, given its geographic location, the Philippines experienced numerous threats to food security brought about by strings of natural calamities that have rendered farm produce unusable or increased food prices due to food shortage;

WHEREAS, COVID-19 pandemic has further worsened the country's food security, disrupting the availability and access to free and nutritious foods at affordable process;

WHEREAS, the Philippines ranks 68th of the 116 countries assessed for experiencing hunger globally;

WHEREAS, with a score of 16.8, the Philippines had a moderate level of hunger according to the 2021 Global Hunger Index;

WHEREAS, to address the problem of hunger and food insecurity in the Philippines, the national government enacted several laws and implemented various initiatives and strategies to ensure sustainable and resilient production and food availability throughout the country;

WHEREAS, food insecurity remains a challenge in the country due to food shortage and rising food prices brought by natural calamities and disasters, health crises such as the COVID-19 pandemic, among others, hindering economic growth and national development;

WHEREAS, the Department of the Interior and Local Government thru its Memorandum Circular 2023-001 shows its support in cognizant of the role of barangay as essential partners of the national government in contributing to address hunger and ensuring food security in the country thru the Halina't Magtanim ng Prutas at Gulay (HAPAG) sa Barangay Project;

WHEREAS, HAPAG project aims to strengthen the capacities of barangay towards sustainable agriculture initiatives. One of which is the intensification and fostering of agricultural activities and communities will be encouraged to produce fresh, healthy and affordable fruits and vegetable from their backyard spaces, through the establishment of community gardens in the barangays with vacant areas.

NOW, THEREFORE, BE IT ORDAINED, by the Sangguniang Barangay of Barangay Cataggaman Nuevo, Tuguegarao City, Cagayan, in regular session assembled:

Section 1. TITLE

This Ordinance shall be known as the HAPAG Ordinance of Barangay Cataggaman Nuevo, Tuguegarao City, Cagayan

Section 2. DECLARATION OF POLICY

- 2.1 To encourage the practice of agriculture that will provide food on the table of needy families in the community;
- 2.2 To create greener and productive spaces in the city, curbing the increasing problem of air pollution and other negative impact of commercialization;
- 2.3 To use agricultural techniques that will reduce the cost required to transport food, making healthier foods more readily available to the public and provide food sustainability in the city;
- 2.4 To enhance productivity by making use of idle lots and open spaces;
- 2.5 To alleviate poverty through self-sustaining programs such as backyard to table food programs, thereby encouraging residents to grow fresh organic fresh produce in the comfort of nearby community spaces and even in the own home;
- 2.6 To create and maintain a network of green spaces in order to maintain a healthy biodiversity.

Section 3. DEFINITION OF TERMS.

As used in this Ordinance, the following terms shall:

- 3.1 Barangay Community Garden - a piece of land or several patches of land operated and cultivated by the barangay for the purpose of planting and growing vegetables and fruit bearing trees;
- 3.2 Container gardening - micro model farming where family unit or household is producing fruits and vegetables in special containers for special consumption;
- 3.3 Fruit Bearing Tree Planting - refers to the planting of fruit bearing trees for food production purposes such as papaya, bananas, mango, etc;
- 3.4 Hydroponics - a method of growing food using the mineral nutrients solutions on water without soil;
- 3.5 Square Foot Gardening - is a simple method of creating small orderly and highly productive kitchen garden;
- 3.6 Vertical Gardening - special kind or urban gardening sustainable for small spaces, particularly for decorating the walls and roofs in various styles. S

Section 4. MANDATORY ESTABLISHMENT OF BARANGAY COMMUNITY GARDEN

- 4.1 It is hereby prescribed that Barangay Cataggaman Nuevo, Tuguegarao City, Cagayan shall establish its own community garden to be Zone 07 Maramag Street (One Dream, One People).
- 4.2 It shall have at least a minimum of one hundred 100 square meters of land area or its equivalent patches of land consisting of at least eight (varieties of vegetables or fruits bearing trees).
- 4.3 Barangay Cataggaman Nuevo, Tuguegarao City, Cagayan shall encourage their residents to set up their family vegetable garden and / or plant fruit bearing trees in available open spaces.

4.4 The Sangguniang Barangay Chairman of the Committee on Agriculture, in cooperation Sangguniang Barangay Chair Committee on Environment Protection shall be focal person in maintaining and sustainable the community garden.

Section 5. **OPEN SPACES IN PUBLIC SCHOOLS**

Cataggaman Nuevo Elementary School shall develop a vegetable gardening area within the school premises. Fresh produce shall be incorporated in healthy canteen food programs of the said schools; or used in feeding or donation/ relief programs of the school. This shall be implemented in partnership with the Parent-Teacher Association of Cataggaman Nuevo Elementary School.

Section 6. **PRIVATE OPEN SPACES**

Idle lots owned by private individuals within the territorial jurisdiction of Barangay Baranga Cataggaman Nuevo, Tuguegarao City, Cagayan may convert their lots into a vegetable garden to be operated by them or by the barangay through any form of legal arrangement with the owner until such time that development on the lot shall commence.

Section 7. **COLLABORATION WITH THE PRIVATE SECTOR**

The efforts of the civil society organization in promoting organic gardening prior to the passage of this ordinance are recognized. The Barangay is encouraged to enjoin the participation of the private sector in the promotion, propagation development, and implementation of organic agriculture from the production and use of agricultural bio-system techniques.

Section 8. **CAPACITY BUILDING**

To sustain and broaden the base for the implementation of this ordinance within sixty (60) calendar days from the effectivity of this ordinance and periodically thereafter, the barangay shall coordinate with the Tuguegarao City Agricultural Office on the conduct of orientation, seminars, and trainings for the development and proper care of the barangay community garden.

Section 9. **PROMOTION OF URBAN ORGANIC AGRICULTURE**

The barangay shall endeavor to promote urban organic gardening by utilizing new technologies and taking advantage of ecological solid waste.

Section 10. **SUSTAINABILITY AND INSTITUTIONALIZATION**

The Barangay Nutrition Committee (BNC) of the barangay shall maintain a record of stunted and severely stunted children ages 0-59 months and shall be the primary beneficiaries of the organic produce of the barangay community gardens. Beneficiaries may also include the indigent members of the community. Documentation on

Section 11. APPROPRIATION

The Barangay shall appropriate and substantial budget to ensure the implementation of this Ordinance and to support the Barangay Community Gardening.

Section 12. SEPARABILITY CLAUSE

If any part of this ordinance is declared unconstitutional, the remaining parts unaffected shall continue to remain valid and in effect.

Section 15. REPEALING CLAUSE

All ordinances, executive orders, rules and regulations contrary to or inconsistent with the provisions of this ordinance or any part thereof are hereby repealed or modified accordingly.


Section 16. EFFECTIVITY CLAUSE

This ordinance shall take effect fifteen (15) days after publications.

SECTION 4. Funding


Funds for the implementation of this Ordinance shall be appropriated from the Barangay Gender and Development (GAD) Fund, subject to availability and existing government budgeting rules.






