WHEREAS, the mandatory Officers Training Courses offered by NPC is designed to develop quality and excellence in the management and leadership of the overall enhancement of public safety and the criminal justice system;

WHEREAS, the NPC is the counterpart of the National Defense College of the Philippines (NDCP), the Joint Command and General Staff College (JCSC) and the Training Command (TRACOM) of the Armed Forces of the Philippines;



WHEREAS, the NPC provides the continuing education and career training needs of the officers of the uniformed services of the Philippine National Police (PNP), Bureau of Fire Protection (BFP) and Bureau of Jail Management and Penology (BJMP);

WHEREAS, the Public Safety Officers Basic Course (PSOBC) Lateral is a one-year resident training program intended for lateral entry of uniformed commissioned officers with the rank of Police Lieutenant and Police Captain in the police bureau to equip participants with basic knowledge, values, skills, competencies and introductory officers functions and leadership in public safety, especially in the police service;

WHEREAS, after months of Academic Training at the National Police Commission, Camp General Mariano N Castañeda, Silang, Cavite, the Public Safety Officers Basic Course (PSOBC) Lateral Class 2023-07 held their Commencement Exercises last December 19, 2023 at the SMX Convention, Pasay City;

WHEREAS, during the said commencement, **PCPT JOHN REIÑER G. MANADAO** was awarded the Dr. Jose Rizal Academic Excellence Award for having finished top 5 of his class, composed of 52 with a final grade of 95.040% of the Public Safety Officers Basic Course (PSOBC) Lateral Class 2023-07;

WHEREAS, the Tuguegarao City Government recognizes individuals who have brought recognition and honor, worthy of admiration and emulation.


