

ORDINANCE NO. 01 – 2024

AN ORDINANCE MANDATING CURFEW HOUR OF BILLIARD HALLS AT 10:00 O’CLOCK IN THE EVENING TO 5:00 O’CLOCK IN THE MORNING AND PROHIBITING MINORS TO PLAY AND IMPOSING PENALTIES THEREOF

WHEREAS, Tuguegarao City ordinance no. 46-08-2020 titled “An Ordinance Imposing curfew Hours in Tuguegara city from 12 Midnight to 4AM Providing Exemptions and Penalties and Therefor and For Other Purposes;

WHEREAS, Republic Act No. 9344 otherwise known as the “*Juvenile Justice and Welfare Act of 2006 as amended by RA 10630*” was passed into law that covers the different stages involving children at risk and children in conflict with the law from prevention to rehabilitation and reintegration;

WHEREAS, in the interest of public order and safety, it is imperative to regulate the movement of minor children especially during night time to protect them from neglect, exploitation, abuse and cruelty and other conditions prejudicial and detrimental to their well-being and development;

WHEREAS, billiard halls are recreational as well as gambling places of both adults and minors alike in the barangay;

WHEREAS, notwithstanding the curfew hours set by the City Government, minors and adults are still seen playing in billiard halls and loitering around the streets in the barangay;

NOW, THEREFORE, on joint motion of all members present, be it **ORDAINED** by the Barangay Council in session assembled to enact Ordinance No. 01-2024, an “**An Ordinance Mandating Curfew Hours of Billiard Halls 10:00 PM to 5:00 A.M. and Prohibiting Minors to Play and Imposing Penalties Thereof**”.

SECTION 1. TITLE. This ordinance shall be known as “**An Ordinance Mandating Curfew Hours of Billiard Halls 10:00 PM to 5:00 A.M. and Prohibiting Minors to Play and Imposing Penalties Thereof**”.

SECTION 2. OBJECTIVE. The Ordinance is enacted in the interest of public order and safety, and to protect and to regulate the movement of minor children especially during night time to protect them from neglect, exploitation, abuse and cruelty and other conditions prejudicial and detrimental to their well-being and development.

SECTION 3. COVERAGE. The Ordinance cover all Billiard Halls in Barangay Centro 10.

SECTION 4. ENFORCEMENT OF THE ORDINANCE. Billiard Hall owners shall be notified of the Ordinance and its effectivity. Billiard Hall owners should not allow minors to play and during curfew hours, the hall must already be closed. The Punong Barangay, Kagawads of the Sangguniang Barangay and duly appointed Barangay Tanods are hereby authorized to monitor the operation of the Billiards. They are likewise authorized to apprehend and to hold in custody for safety minors violating this ordinance. The parents should be duly notified for proper guidance.

SECTION 5. PENALTIES

- A. First Offense – stern warning for closure
- B. Second Offense – temporary closure for one (1) month
- C. Third Offense – cancellation of permit to operate and permanent closure

SECTION 6. SEPARABILITY CLAUSE. If for any reason, any section or provision of this Ordinance is declared unconstitutional or invalid by a competent court, the remaining sections or provisions not affected thereby shall continue to be in full force and in effect.

SECTION 7. REPEALING CLAUSE. Local ordinances or legislations inconsistent with this Ordinance are hereby modified or repealed.

SECTION 8. EFFECTIVITY. This ordinance shall take effect immediately upon approval.





ORDINANCE NO. 02 – 2024

AN ORDINANCE PROHIBITING PEER DRINKING ALCOHOL ALONG THE SHOULDERS OF THE MAJOR STREETS OF BARANGAY CENTRO 10 IMPOSING PENALTIES THEREOF

WHEREAS, the Local Government Code as stipulated in Section 388 states that *For purposes of the Revised Penal code, the Punong Barangay, Sangguniang Barangay Members and members of the Lupong Tagapamayapa in each barangay shall be deemed as persons in authority in their jurisdictions, while barangay officials and members who may be designated by law or ordinance and charged with the maintenance of public order, protection and security of life and property, or the maintenance of a desirable and balanced environment, and any barangay member who comes to the aid of persons in authority, shall be deemed agents of persons in authority.*

WHEREAS, one of the functions of the members of the Sangguniang Barangay pursuant to the Local Government Code is to adopt measures towards the prevention and eradication of drug abuse, child abuse, and juvenile delinquency and act as peace officers in the maintenance of public order and safety.

WHEREAS, some residents of the barangay do peer drinking of alcohol along the shoulders of the main streets of Barangay Centro 10 which may cause some fear among the residents and passersby as well as may serve a bad model to the children;

WHEREAS, such scenario does not speak well of the discipline and image of the barangay and may also cause road obstructions.

NOW, THEREFORE, on joint motion of all the members present, be it **ORDAINED** by the Barangay council in session assembled to enact Ordinance No. 02 – 2024, an “Ordinance Prohibiting Peer Drinking Alcohol Along the Shoulders of the Major Streets of Barangay Centro 10 Imposing Penalties Thereof”

SECTION 1. TITLE. This ordinance shall be known as “**An Ordinance Prohibiting Peer Drinking Alcohol Along the Shoulders of the Major Streets of Barangay Centro 10 Imposing Penalties Thereof**”.

SECTION 2. OBJECTIVES. This ordinance has the following objectives:

- to prevent the occurrence of troubles along the roads;
- allay fears among the passersby;
- to clear the roads of obstructions; and
- prevent a bad image of the barangay in terms of discipline and peace and order.

SECTION 2. COVERAGE. This ordinance shall deal with all peer drinking buddies along the main streets of Barangay Centro 10.

SECTION 3. DEFINITION OF TERMS

- Peer Drinking Alcohol – a group of friends drinking liquor together
- Road Shoulder – it is that part of the road which is often serves for an emergency stopping lane, is a reserved lane by the verge of a road or motorway.
- Major Streets – are the main roads or thorough fares of the barangay such as the Valenzuela, Gomez, Gonzaga, Rizal, Aguinaldo and Pilapil Streets.

SECTION 4. ENFORCEMENT OF THE ORDINANCE. The Punong Barangay, Kagawads of the Sangguniang Barangay and duly appointed Barangay Tanods are hereby authorized to monitor the major streets to determine the presence of peer drinking alcohol along the shoulders of the streets. They are likewise authorized to apprehend and to hold in custody those violating this ordinance and submit a written report to the Office of the Punong Barangay.

SECTION 5. PENALTIES

- First Offense – Community Service in the Barangay
- Second Offense – fine of P500.00 each offender
- Third Offense – fine of P1,000.00 each offender

SECTION 6. SEPARABILITY CLAUSE. If for any reason, any section or provision of this Ordinance is declared unconstitutional or invalid by a competent court, the remaining sections or provisions not affected thereby shall continue to be in full force and in effect.


SECTION 7. REPEALING CLAUSE. Local ordinances or legislations inconsistent with this Ordinance are hereby modified or repealed.


